## Ilocos Sur Gov, mayors quit LDP

Gov. Mariano Tajon, Vice Gov. Deogracias V. Savellano, the eight members of the provincial board, 34 mayors, and 769 heads of the province's barangay councils announced yesterday their resignation from the Laban ng Demokratikong Pilipino (LDP).

The announcement was made by Tajon following the meeting of the group last Friday, presided over by Candon Mayor Eduardo Guirnalda who is president of the Ilocos Sur Mayors League.

Tajon said the mass resignation was sparked by their leader, Ilocos Sur Congressman Luis "Chavit" Singson who heads the 29-strong

VIGAN, ILOCOS Sur - Northern Luzon Alliance (NLA) bloc in Congress.

> Tajon stressed his group will maintain its independent status and will continue to support the leadership of President Aquino.

> "Politics must be set aside in these crucial times, and more attention should be given to the determined and sincere pursuance of activities and programs to provide more services to our constituents," Singson stated.

> Tajon, on the other hand, emphasized that the resignation of his group from the LDP has "absolutely nothing" to do with the resignation of Speaker Ramon V. Mitra Jr. as founding LDP president.

He said the LDP has not given Ilocos Sur due recognition and importance, especially in the form of assistance when the province was ravaged by Typhoons "Goring" and "Openg."

## Luisita's armed guards denounced

MILITANT Kilusang Magbubukid sa Pilipinas (KMP) yesterday denounced the existence of a so-called private army in the Hacienda Luisita, saying that the armed guards are sowing terror among the farmers there.

KMP Chairman Jaime Tadeo said in a radio interview that the Hacienda, owned by the family of President Aquino, has become a "model of the CAFGU (Civilian Armed Forces Geographical Unit) instead of the CARP" (Comprehensive Agrarian Reform Program).

Calling the armed men inside the sprawling estate as members of a "Yellow Army", Tadeo charged that other landowners especially in Negros have followed the example in Luisita, arming their own men to be pitted against the farmers.

Another peasant leader in Luisita, Alex Gonzales, meanwhile, rejected the

proposal to hold a referendum on Nov. 8 among farmers to determine what mode of agrarian reform they want: stock transfer (as already implemented by the Cojuangcos, a move that was severely criticized as going against the spirit of the CARP) or outright land transfer.

Gonzales said that the farmers would rather favor owning a piece of land in the Hacienda, instead of a piece of paper (stock certificates).

## Another look at Malacañang's 'bribe' attempt

KAY, THE press has already shut its mouth over the matter, when just last September 21 it screamed with such headlines as TARLAC GROUP BARES PALACE 'BRIBERY' TRY, and on the next day every columnist offered his two centavos' worth.

Apparently, the press has taken the President's word for it: "No bribe try" from her and Budget Secretary Guillermo Carague, contrary to the allegations of the Tarlac Anti-Graft Council (TAGC) officials before the Senate Blue-Ribbon Committee. The TAGC brass had accused Ms. Aquino and Carague, who are both Tarlaquenos, of attempting to bribe some of them so that they'd keep silent on the irregularities involving "Cory's Choice" Gov. Mariano Un. Ocampo III. The "bribe" was in the form of job offers in the well-financed Lingkod Tarlac Foundation and the provincial government's Pre-Qualifications, Bids and Committee Awards (PBAC).

Listen to the President explain her side: "The offer was made... so that they can monitor what was happening and they could denounce any impropriety that the Tarlac local officials might be committing. . . I have made similar offers to other NGOs (nongovernmental organizations) and PVOs (private volunteer organizations). In fact, I have institutionalized the system by creating the regional and provincial organizations."

Echoed Carague: "It was an honest-to-goodness offer by the President for them to actually be part of the process so that they can have a firsthand knowledge of the goings-on instead of relying on rumors. If you consider that as a bribe, well, I don't




#### WHAT THE LAW SAYS

The Revised Penal Code deals with bribery in three provisions (Arts. 210 to 212), but none is squarely applicable in Cory and Carague's case. Art. 210 (Direct bribery) penalizes a public officonsideration of an offer and performance of his official direct or indirect bribery."

A related law, P.D. 46, penalizes a government employe who receives gifts from private persons on any Christmas inoccasion,


There's also the recently enacted Code of Conduct and Ethical Standards for Public Officers and Employes (R.A. 6713), which requires of all government personnel to be models of rectitude and dedication to duty. The President herself signed the code into law.

Above all there is Cory's own 1987 Constitution. which among other things demands "honesty and in-

tegrity in the public service" (Sec. 27, Art. II) and utmost integrity among public officers and employes (Sec. 1, Art. XI).

In the light of all these laws, judge for yourself, reader, whether or not Her Excellency and her alter ego, Carague, committed bribery.

To be sure, the President and Carague cannot invoke ignorance of the law, it being the presumption that everybody knows the law.

And the President knows the law. Otherwise, she would not have said this:

"Firstly, if indeed a bribe attempt was made at the meeting, why did the reaction to it come more than a month later?

"Secondly, would a bribe be offered within hearing of such a big assemblage?

"Bribery is often very hard to substantiate because it is usually made in a very discreet manner with a minimum number of persons being privy to it."


Gillego's reaction reflected that of the LDP majority in the Lower House. But to the Opposition, it was something else. "It is lamentable," said Minority Floor Leader Rodolfo Albano of Isabela, "that a highest official of the land would attempt to silence a probe into the anomalies being committed right in her home prov-

Bribery is a ground for impeachment, but Albano said the Opposition would still determine if there is sufficient basis to initiate impeachment proceedings against the President. To date, nothing else has been heard from Albano.

#### CARAGUE'S OUSTER

But while they could be charitable to the President, the congressmen have demanded Carague's ouster because of his "involvement in the reported coverup" of anomalies in the provincial government of Tarlac. According to Rep. Gregorio Andolana of North Cotabaic, the national government through Carague has Tarlac "financial", made obese and public-works heavy" while other provinces, especially those in Mindanao, "are cash-starved and (are) made to live on

crumbs." In so-called development funds afone, Tarlac was reportedly allotted P900 million by the Department of Budget and Management.

Yes, but the amount is public works money for three years, from 1986 up to 1989, Carague answered. Other provinces have larger appropriations, but Carague didn't say if these cover a period of three years or if these appropriations are intended for larger projects than those meant for his and Cory's homeprovince.

At any rate, Carague will remain as Budget Secretary, said the President last September 22. True to her character, she absolved Carague, thus: "There is... no reason to talk about Secretary Carague's resignation or going on leave."

To paraphrase the Latin maxim "Roma locuta, causa finita," Cory has spoken, the matter is finished - unless congressmen like Ronaldo Zamora (LDP, San Juan-Mandaluyong) push thru with their plan to charge Carague with technical malversation for allocating money for Tarlac other than what was indeed under existing laws, particularly the General Appropriations Act. Zamora said that under the 1989 budget only P46 million, and not P900 million, was alloted for Tarlac's infrastructure.

Will Zamora, a KBLturned-LDP, have the guts to go after the head of one of Cory's favorites?

The answer remains to be seen.

Meantime, Ocampo has blamed a man living 12,000 miles away from Tarlac as the mastermind of the "bribery" caboodle. As the Manila Times (September 27) reported it, the bribery raps are all part of a destabilization plot hatched by Cory's cousin but Marcos boy Danding Cojuangco. Ocampo said Danding really wants to

topple Cory to pave the way for his return to the Philippines.

Poor Danding. The tentacles of his business and political empire are supposed to have been slashed at EDSA in 1986, and here he is, an exile in the last three years, charged with masterminding a diabolic scheme half a world away.

Can't Cory's favorites think any better?

As regards the "bribery" attempt, forget it. It may be the first of its kind in the history of Malacanang, but as the President said, it's legal — and, perhaps, moral as well.

# More workers join unions

MANY WORKERS in or various industries are realizing the benefits of organizing themselves to protect their interests, signifying a growing awareness among the blue-collared sector of their legislated rights.

A survey on unionism and collective bargaining conducted by the Bureau of Labor and Employment Statistics (BLES) shows that there are now 11,500 or 28 percent of 41,000 non-agricultural establishments employing 10 and over personnel which are organized or unionized.

Industrywise, manufacturing had the most number of unionized establishments at 44 percent. Region IV (Southern Tagalog) had the highest percentage of unionized firms (36 percent) although 47 percent of the total unionized companies are located in the National Capital Region (NCR).

In terms of union membership, the BLES survey revealed over one-third or 39 percent of the total 4.5 million employed are organized. The highest percentage of organized workers are engaged in mining and quarrying (63 percent). Region I (Ilocos) had the most number of organized workers in proportion to its employment (61 percent), although NCR had the highest number of organized workers at 812,500.

The survey also indicated that about 66 percent of unions with collective bargaining agreements have the union itself acting as its exclusive bargaining agent, while 30 percent rely on their federations. Eighty-eight percent of current CBAs have an effectivity period of three years, six percent for two years and less than one percent lasts a year. Moreover, CBA coverage reached 1.756 million or 39 percent of the 4.529 million em-

On the other hand, more than one-fourth (27 percent)

or 11,000 firms have adopted labor-management cooperation (LMC) schemes which seek to improve labor-management relations and enhance working conditions and productivity gain-sharing plans. About



2.4 million workers or 53 percent of the total employment were covered by various LMC programs, majority (63 percent) of whom are in the manufacturing sector.

Meanwhile, another survey on establishment practices and policies showed there are 41,000 nonagricultural establishments employing 10 and over throughout the country, mostly having salaried workers (79 percent) or those being paid monthly. Timerated wage earners were found in about 24,000 firms or about 67 percent fixed their wages on a daily basis.

Wage setting is commonly done through individual agreement between the employer and worker (38 percent), employer's decision (31 percent), legislation (24 percent) and CBA (11 percent).

Twenty-one percent of the total number of establishments provided cost-of-living allowances to their workers while 34 percent granted bonuses and gratuities, with the salary of workers as the primary consideration. Only 18 percent grant these wage supplements based on net profits, the survey revealed. (ANF)

# Bring the Marcoses back'

PRAYER

WHEREFORE, IT is respectfully prayed that the Court reconsider its decision of September 15, 1989, and in lieu thereof, render a new decision:

a. Ordering the issuance of a writ of mandamus directing the respondents, particularly the Department of Foreign Affairs, to issue the necessary travel documents to enable Mrs. Imelda R. Marcos, Ferdinand E. Marcos Jr., Irene M. Araneta, Imee M. Manotoc, Tommy Manotoc and Gregorio Araneta to return to the Philippines.

b. Ordering the issuance of a writ of prohibition restraining and enjoining the respondents and all persons acting on their orders or in their behalf, from implementing in any manner whatsoever the decision of the President and the Cabinet Crisis Committee to bar the transport to the Philippines of the remains of former President Ferdinand E. Marcos and the return to the Philippines of the other petitioners.

#### ARGUMENTS

A. In so far as former President Marcos is concerned, the instant petition was brought primarily to enable him to come home and die here, and to be buried here. His death should completely remove apprehensions, however unfounded, as to both his intent and capability to "destabilize" conditions in the country. As for the petitioners Imelda R. Marcos, Ferdinand R. Marcos, Jr., Imee M. Manotoc, Tommy Manotoc and Gregorio Araneta, they have gone to the United States only to accompany former President Marcos. His death has only made their return to the Philippines more impelling.

The Constitution, the rights of man, equality before the law, justice – these were the foundations of the petition. The death of President Marcos has added other dimensions – Christianity, humanity.

dressed to the decision of this Court rendered when President Marcos was alive. We submit that they apply (Summary of motion for reconsideration for the homecoming of the late President Marcos, filed with the Supreme Court on October 2, 1989, G.R. 88211).

with more reason to have his remains buried in the Philippines. As to his family, his death has only made respondents' arguments barring also the members of his family from returning to the Philippines even less persuasive.

B. To bar former President Marcos and his family from returning to the Philippines is to deny them not only the inherent right of citizens to return to their country of birth but the protection of the Constitution and all of the rights guaranteed to Filipinos under the Constitution.

How can a Filipino have his abode in the Philippines if he is barred from the Philippines? How can he travel "from the Philippines to other countries or within the Philippines" if he is in a foreign land?

The right to life, to liberty, to property -- these rights to be enjoyed by Filipinos in the Philippines and not elsewhere. The Philippines is every Filipino's homeland. To live here is his birthright. The Constitution does not by its language or its nature show that this right has been yielded to government—least of all to the President.

The Constitution may not by explicit language protect the right of the Filipino to return to the Philippines; it is simply because the right inheres in the citizenship of a Filipino and its denial destroys the very foundation of a democratic state.

CITED

Worthy vs. US - The right to travel has three aspects - the right to go anywhere within the country; the right to leave one's country; and the right to return to his country. While the right to leave the country may, by law, be regulated by the requirement that passport be secured for the purpose, the right to return is absolute and not subject to regulations because a citizen

has an inherent right to return to his country.

US vs. Wheeler - The US Supreme Court has recognized that the citizens of a state possess the "fundamental right, inherent in citizens of all free governments peaceably to dwell within the limits of their respective states, to move at will from place to place therein, and to have free ingress thereto and egress therefrom..."

C. The President has no power to bar a Filipino from his own country; if she has, she has exercised it arbitrarily. Such powers cannot include those denied to the President by the Constitution.

President Aquino herself disavowed any reservation of power to the Presidency even in an emergency. Addressing the Congress on July 24, 1989, she said:

"Our swift democratization was done against the advise that I reserve emergency powers in the face of

rising military adventurism and communist terrorism. But I believed then — and time has proved me right — that this nation shall find no greater source of all its rights and liberties. Democracy is our faith and the root of our strength to defend it."

Those who wrote the 1987 Constitution deliberately took care that the President would not have the powers of the President under the 1935 and the 1973 Constitutions. Yet, the "residual" powers of the Court now state that the President has powers which even the President under the 1935 and 1973 Constitutions did not have or invoke.

Amendment 6 of the 1973 Constitution which explicitly vests in the President residual powers was repudiated by the framers of the 1987 Constitution but the Court now rules that the President possesses such powers.

What is called residual powers must of necessity be executive in character and not legislative nor judicial.

The power to regulate, the exercise of constitutional rights or police power, is exercised through the legislative branch by the enactment of laws. It is not the President, but Congress, which has the residual power.

The right to abode and the right to travel are but aspects of the Filipino to return to the Philippines. The President cannot impair this right to return, because the Constitution denies to her that power.

The Court does not find that "national security" and "public safety" considerations exist to justify the barring of former President Marcos and his family from the Philippines. In fact, there is no record that the President has made such a claim. Nor has she invoked any law giving her authority. There is, indeed, no law.

Rather, the Court relies on alleged need to protect the "general welfare of the people" to "protect the peace," the "maintenance of

peace and order," the need to insure "domestic tranquility in times when no foreign foe appears in the horizon."

No right guaranteed by the Bill of Rights can be absolutely denied or even limited without any law and on such broad considerations. No prior restraint can be imposed for the exercise of the freedom of speech or freedom of the press.

The right against unreasonable search or arrest or against self-incrimination are inviolable even if it should mean acquittal of persons who have violated the peace. And so with all other rights. Even if impairment is permissible, the limitation must meet the clear and present danger test.

The 1987 Constitution allows the President lesser prerogative over the liberties of the people even when there is an invasion or a rebellion and martial law is proclaimed than what the Court has allowed the President to do in times of peace and when no foreign foe appears in the horizon.

There cannot be any preventive detention and yet the case now is worse. President Marcos and his family are barred from returning to the Philippines only because of what the Court calls the "catalytic effect" the return of former President Marcos may have. It is not even suggested that he will lead a rebellion nor even join such a movement. Indeed, he is undoubtedly incapable of doing so.

Even in case of invasion or rebellion, the President is without power to deny rights to even those who may have committed treason or rebellion. She may at most order detention for three days and not for preventive purposes, but because of the commission of treason or rebellion. After three days, only a court may authorize continued detention.

The Court's ruling has dangerous implications. Under this ruling, all of the

rights of the Filipinos under the Constitution are subject not to a power the Constitution confers on the President, but on what the Court refers to as the President's residual power. The Court establishes the potentials of a dictatorship.

CITED: Comment of Fr. Joaquin G. Bernas on the Supreme Court decision as penned by Justice Irene Cortes.

She said there was no point for Mr. Marcos to appeal to the Bill of Rights because the Bill of Rights contains no provision protecting the right to return to one's country. She arrived at the conclusion by performing an emasculating surgery on the Bill of Rights. But she did more than that. Having reduced the protection given by the Bill of Rights, she proceeded to expand the powers of the presidency at the expense of the court. A double or even a triple whammy of sorts.

Justice Cortes says that the issue is basically one of power. Ironically, in reading a Constitution that is wary of executive power, Justice Cortes sees no "unstated rights" in the Bill of Rights, but discovers "unstated powers" which the President can fall back on.

The Constitution itself recognizes the principle of equality before the law: justice. These would be meaningless if there is one law for the Marcoses and another law for all others. It will not

do for the Court to state that his case "should not create a precedent."

Without the power to bar a Filipino from returning, the President not only violates the Constitution but also acts arbitrarily in banning the Marcoses from returning.

The Court made factual findings, although there is nothing on record in which the President had represented the factual conclusions that the Court made. This is both unprecedented and unwarranted. The Court has become more popish than the Pope.

President Aquino has herself contradicted many of the factual findings of the court: "We are well on the road to recovery; investment increase...posted a 6.7 percent growth...foreign countries paid tribute to the country's growth and political achievements, the tide has turned permanently with regard to insurgency, etc. etc."

What is on record is a mere newspaper report of a statement attributed to her. The pleadings of parties are not evidence. Nor the oral arguments made by the lawyers.

President Aquino has never responded to the appeals of the Marcoses directly. She has never communicated to them. The Marcoses have never been officially advised as to why they have been barred from returning. No hearing has been held within the Executive Department at which

the Marcoses have been informed why. Whatever facts have been used by President Aquino made up the conclusion reached in violation of their rights to due process. The facts derived from the briefing by the Chief of Staff are highly disputable.

#### CITED:

Opinion of Justice Gutierrez: "I must emphasize that Gen. De Villa assured the Court that a rebellion will not succeed and that the military is on top of the situation. Where then is the clear danger to national security? The Court has taken judicial notice of something which even the military denies.

Justice Cruz: "In about two hours of briefing, the government failed dismally to show that the return of Marcos dead or alive would pose a threat to the national security as it had alleged. The fears ... were based on mere conjectures of political and economic destabilization without any single piece of concrete evidence to back up their apprehensions."

Justice Paras: "Our Armed Forces have failed to prove this danger. They are bereft of hard evidence, and all they can rely on is sheer speculation."

Justice Padilla: "It appears to me that the apprehensions entertained and expressed ... do not escalate to proportions of national security or public safety. They appear to be more speculative than real, obsessive

rather than factual."

Justice Sarmiento: "We have persistent claims made by the military top brass ... that this government will not fall should the first family in exile step on Philippine soil."

The Court even spoke of a "separatist movement in Mindanao." The movement did not even merit a word in President Aquino's 1989 State-of-the-Nation address. We cannot be certain that President Aquino herself agrees with the Court.

The Court spoke of "rightist conspiracies," but President Aquino has dismissed such as no more than the "delusion of self-importance and the realities of power of military adventurers."

One hundred and three congressmen covering the breadth of the country urged the President to allow President Marcos to come home to die here because they felt that his return would serve national interest. They declared that the ban "would further exacerbate the bitterness, hatred and partisan divisions that now burden our people, warping the national will to move as one community in the pursuit of common aspirations.

The Court referred to a "documented history of the efforts of Marcos and his followers to destabilize the country," but these documents were never shown. No charge accusing President Marcos of any crime, much less for a crime affecting na-

tional security or public order has been filed against him or any member of his family.

The country is beset with problems affecting its political stability, but they are problems not even remotely connected to the return of President Marcos and his family.

Not a few believe that the principal cause of the country's woes is imputable to a failure of leadership.

## Rift on the referendum issue

CAN THE Filipino people be consuited on the fate of the United States military facilities here before a new bases treaty is submitted for concurrence to the Senate?

Malacanang, the House of Representatives and the Senate are divided on the subject, each citing the Constitution.

Speaker Ramon V. Mitra, with whom President Aquino concurs, is proposing a referendum on a new bases treaty after negotiations but before it is submitted to the Senate for ratification.

Mitra cites Section 16, Article 13 of the Constitution, which states: "The right of the people and their organizations to effective and reasonable participation at all levels of social, political, and economic decisionmaking shall not be abridged. The State shall, by law, facilitate the establishment of adequate consultative mechanisms."

Senate President Jovito Salonga and Senate Minority Floor Leader Juan Ponce Enrile cite Section 25 of Article 18 (Transitory Provisions): "After the expiration in 1991 of the Agreement.... foreign military bases, troops, or facilities shall not be allowed in the Philippines except under a treaty duly concurred in by the Senate and,

when the Congress so requires, ratified by a majority of the votes cast by the people in a national referendum held for that purpose, and recognized as a treaty by the other contracting State."

Rep. Bonifacio Gillego's stand differs from the majority view in the House: "Section 25 does not allow the continuance of the Military Bases Agreement after 1991 except under the following conditions.

"1. under a treaty concurred in by the Philippine Senate with at least two-thirds vote of all its members (Section 21, Article 7);

"2. after the Senate ratifies the treaty, only

then can Congress submit the treaty to the people in a national referendum ("Military Bases," Guide Notes on the Constitution of the Philippines, 1987, Legislative Research Unit of the Constitutional Commission);

"3. when the treaty is recognized by the other contracting State, in this case the Senate of the United States."

Mitra contends that there is no legal impediment to holding a referendum before the Senate ratifies the treaty.

## The Marcos will

HE Presidential Commission on Good Government (PCGG) may have hit on something relevant and sensible when it challenged Imelda Marcos to disclose to the public the real score about her husband's last will and testament. According to her, Marcos had prepared a will before he died leaving all his worldly possessions to the Filipino people.

The PCGG had expressed great doubts about the sincerity of Imelda's statement, as in fact one of its commissioners even stated that she may just be bluffing. Knowing the widow, the PCGG's apprehension would find common cause with the public's perception of her disclosure as simply a ploy to fool the people, a practice the couple had perfected in their 20 years of abusive rule. In her panic to escape the clutches of American laws and its impartial system of justice, Imelda will say and do anything, like going down on her knees in supplication, for the return of her husband's remains to the Philippines. Which she will accompany, of course.


It was a good turn of events that the PCGG has seen through the deception. Speaking before media, Commissioner Rosalio de Leon dared Imelda to furnish the PCGG a copy of the supposed will to erase all doubts about its existence. Even the Marcos lawyer, the one man who should know, does not seem to be aware at all about it. "If her intention is really sincere," De Leon said, "she should take the initiative to give us a copy of the will." And nobody who could claim any degree of closeness to Marcos while he was alive has been given any idea on how the dictator wished to dispose the vast wealth he stole and accumulated during his rule.

Thus the PCGG cannot be faulted for being "intrigued" and to doubt Imelda's revelation from Hawaii that her late husband had decided to leave his "worldly possessions in the service of the Filipino people." In exile he adamantly refused the offer of reconciliation and forgiveness on condition that he return to the Philippine Treasury the wealth amassed from the sufferings of his countrymen. He clung like a leech to his money, why should he surrender it now?

The PCGG should remember that Marcos could have prepared a last will and testament last year when his health could have yet allowed him. In January of this year he entered the hospital, which he never left and was comatose for several months before his death. If there had been a will, it should have been written in 1988 and his attending lawyer would be the first to know about it since he would most probably have been tasked to write the same. Yet the man is in the dark about the will.

It has been reported that the Commission chairman has left for the United States and Switzerland to press the government's claim on the Marcos deposits in the foreign banks. The last time he was out of the country, Mateo Caparas decided, on a brilliant spur of the moment, to drop by Honolulu perhaps to see how the Marcoses are faring in their allegedly rented Makiki Heights mansion and to discuss the weather in sunny Hawaii. He never volunteered the information until it leaked from the blue and then he was beside himself trying to explain the detour that the lady President had not authorized.

Now he is out of the country again and there was no announcement that he will stop over in Honolulu on the way back to condole with the widow. He could be overlooking a good bet; for all her histrionics, Imelda's guard could be down at this time. It might do the PCGG's cause a world of good to discuss with the grieving widow the finer points of restitution and its cleansing effect on the conscience, the alleged Marcos will, and the return of his body to the country he loved and robbed so well. After more than three years, the PCGG might yet accomplish something tangible in the recovery of the Marcos billions.




## Sin casts first stone

JESUS CHRIST, a mere layman, upstaged the lawyers and magistrates of His time by successfully defending a woman caught in the act—in flagrante delictu (this was misprinted in our October 3 column) of adultery which may be defined as smuggling of semen or illegal entry of the gun used for the transmission of life. cember 9, 1935, where he was awarded the honorary degree of doctor of laws along with US President Franklin Delano Roosevelt, was his emphatic assertion that "The sovereignty of this Republic is shared by all, possessed by none, that the authority of government may never be presumptive or arbitrary but only representative and revocable...

"The State, then, can never become coequal with the community: as could be if processes of government were accepted as embracing the structure and form of society. The community is greater, as well as antecedent to, the State. It creates the State to control and order its multiple interests; interests which citizens never relinquish whether to kings, princes, or parliaments. To mistake this relation, to misread the genealogy of government, is to induce the subservience of the popular to the governmental will. 'Of the people, by the people, for the people' is, therefore, a prepositional summary of the concept of that freedom which the United States enjoys and which, with singular magnanimity, it has conveyed and bequeathed to the Filipino people... And the people, not the State, are sovereign."

This all reminds me of the current debate over whether our people have the right to be heard on the burning question of whether the American military presence is to be retained in our country or not. Since when has the Senate assumed the sole responsibility of deciding what is in the national interest, when this particular national interest involves the very lives and fortunes of our

If the Senate is indeed representative of our people, why is it afraid to know what is

truly in the minds and hearts of our people? In ancient Rome, it was always, Senatus populosque Romanus, or "the Senate and the People of Rome," That is why one sees in pictures of old Rome, the standard "SPQR."

Granting, arguendo, that under the Constitution, the Senate is to ratify treaties, is it not also true, that it may, if it so wills, submit its decision to the people? And that the treaty, if ratified, has also to be acted upon by the other party to the ratification?

The uncontradicted fact is that an overwhelming majority of our people are agreeable to a retention of the American military bases in the Philippines. They have their reasons and it is only proper that their wishes must be respected by the Senate.

As Mr. Romulo says "The community is greater, as well as antecedent to, the State," and citizens never relinquish their interests "whether to kings, princes, or parliaments." The people cannot be subservient to the governmental will. Because "the people, not the State, are sovereign."

I agree with President Aquino and Speaker Mitra that it is needful that our people be consulted on the military bases issue. A referendum, that is. Now, if in spite of the people's decision, the Senate will still want to have its way, so be it.

## The exodus of East Germans

THE WESTERN European press went head over heels on what it called the "dramatic turning point in European history." In recent weeks it has noted with unusual euphoria that the East Berlin bloc was disintegrating, that the Berlin Wall was crumbling, that Gorbachev's "perestroika" and the "glasnost" or restructuring of the once strong socialist bloc were taking place at a breathtaking speed.

Poland and Hungary are changing so fast in a way that signals the end of a communist ideology.

The West "holds its breath as Poland changes direction," says Die Zeit, West German daily.

"Thousands wait in tents for caravans to the West," reported the Kolner Stadt Anzeiger, another big Western German newspaper, in bold headline. The tents were mushrooming up in Hungary, an Iron Curtain country, as thousands of East Germans wait to get into trains to Austria. An estimated 10,000 East Germans have already gone across the Hungarian border to Austria as the armed East German guards merely looked the other way.

In Czechoslovakia, the grounds of the West German embassy and consulate (in Prague) have become a "tent city" that receives thousands of East Germans and Hungarians who wait for transportation to freedom in Western Europe.

The Exodus of the Biblical times, when the Iraelis fled from Egypt, is being reenacted in a 20th century European setting.

In the Eastern hemisphere on the other side of the globe, the Gorbachev moves of glasnost and perestroika are falling on suspicious ears. The hegira which has been taking place for the last four or five weeks has a different reception in our region. The evacuation of communist forces from Cambodia, is suspiciously watched by us. In North Korea, the Soviets still keep them from migrating to their promised land south of the 38th degree N. parallel. And it is another different scene in Japan. Four Japanese islands in the nothern central part of the Japanese archipelago which the Russians occupied by sneak-in tactics when Japan surrendered in 1945, after WW II, and which the Japanese are claiming back, have instead been strongly fortified by the Russians. The


Russians have clung steadfastly to these islands. They are holding a poniard against the jugular vein of Japan with these islands which they, the Russians, have already secured and strongly fortified.

In spite of what has been happening in Europe in the apparent exodus to freedom of "imprisoned" West Germans in East Berlin and the Iron Curtain countries controlled by the Soviets, US Vice President Dan Quayle warned the free peoples of Asia and the Far East in his recent official visits which were just concluded, that Asians should not drop their guard but keep their security treaties with the

"Anybody who thinks you ought to tamper with or rewrite the US-Japan Security Treaty is wrong," Quayle told his audiences in Japan. He invariably hammered on this theme throughout his circuit in Asia and the Far East.

He said, in Misawa and Chitose and other places he visited in Japan, that the US shares Japan's heartfelt desire for the return of several small islands which Japan calls its northern territories.

Quayle did not specify these islands, but



the track record of the Soviets in grabbing lands shows that these islands are: Hagomai, Shikotan, Kunashiri, and Tatruu. They may now have Russian names. The Japanese civilians who lived on these islands were evacuated years ago. Quayle had also in mind the northern half of Japan's Sakhalin island which is also occupied by the Russians. This situation arising also from WW II makes the Japanese constantly wary, tremulous and uncomfortable with their Soviet neighbor.

One effect of the statements of Quayle among free Asians is that it has thrown cold water on the euphoria of freedom-loving peoples of Europe over the apparent demolishing of the Berlin Wall.

Quayle's indomitable words also warned the Filipinos of the dangers of phasing out the US military facilities in the Philippine archipelago.


## Miriam's secret organization

SPEAKER RAMON Mitra's proposal for a referendum on the US military bases should be pursued. In fact it is a constitutional postulate giving the people the right to effective and reasonable participation at all levels. Article XIII, Section 16 is quite clear. It says: "The right of the people and their organizations to effective and reasonable participation at all levels of social, political, and economic decision-making shall not be abridged. The State shall, by law, facilitate the establishment of adequate consultation mechanisms."

The referendum suggested by Speaker Mitra is such a mechanism because I construe this provision to mean that the Constitution itself directs that the people be first consulted and their views be sounded on matters that affect them. Definitely the US bases affect them.

Even during the Marcos regime, with all its repressions, the government resorted to referendum and consultative assemblies. I recall that when I went to the Supreme Court to question the validity of calling for an advance plebiscite on the organization of the Metro Manila Commission, even Justice Cecilia Munoz-Palma voted against me by saying in her opinion that "there is nothing wrong for a President to consult the people once in a while". There was no Article XIII, Section 16 then. Now the Constitution no less mandates it, so why the objection?

I have it on good authority that DAR Secretary Miriam Defensor-Santiago has finally given her blessings to a group of



politicians to launch her presidential bid for 1992. I know it because last Saturday, September 23, I received a phone call from former Congressman, former Governor, former Assemblyman Marcial Pimentel of Camarines Norte who asked me to join the Miriam Defensor for President Movement. Marcial told me that his group has Miriam's blessings and I should join because I come from the same region. I answered that Miriam and I come not only from the same region but from the same province but I cannot join her organization. According to Mr. Pimentel, their organization is still secret but they will go public "after Miriam is confirmed by the Commission on Appointments" and will register a new political party by Janaury 1990. So there you are, all these disclaimers of Ms. Santiago about "not being a politician but an academician" are just a delense mechanism so she can pass through the CA -- the Commission on Appointments, that is. In fact my story got a confirmation from Ex-Assemblyman Salvador Britanico of Iloilo who told me the same story. Now, how will President Cory take this move of her favorite

## Preparation for and conduct of trial-(64)

10.33 Objection to Scientific and Experimental Evidence

AN OBJECTION to scientific evidence is based on the principle of incompetency, that is, on failure to lay a proper foundation.

Foundation: 1) When experimental evidence is offered - for example, skid tests in an accident case - it is necessary to demonstrate a similarity of conditions between the accident and the experiment. It also must be shown that a trained, qualified person conducted the experiment. 2) If a scientific instrumentality or test is involved -- for example, a blood test or chemical analysis - it is necessary to show some scientific acceptance. It is not necessary, however, to establish infallibility or general scientific acceptance. Determination of whether the scientific test or instrument has received enough acceptance by experts in the field to justify its admission into evidence, is a preliminary fact to be resolved by the court.

Courts are becoming more liberal in admitting scientific evidence. Practicalities compel the use of standard scientific instruments, material, and tables, even though hearsay implications may be involved. Judicial notice is commonly taken of the reliability of scientific instrumentalities, materials, and tests. Electrocardiograms, for example, are accepted without offering expert testimony about the scientific principles underlying them.

It is always necessary to call the technician who conducted the test and it may be necessary to call an expert to vouch for the general



scientific acceptance of the instrumentality or test. The technician can testify that the proper procedures were followed, as well as testifying to the test results.

A technician who conducts a test need not understand all of the steps in manufacture of a device, nor does he have to know, for example, in chemical tests, whether the chemicals have actually been properly compounded. He must, however, have reasonably good training and experience in conducting the particular test about which he testifies. If a device such as radar or an intoximeter, is used, the expert/technician must show that it recently has been tested and/or is in good working order, but he need not eliminate all possibility of inaccuracy.

Computer printouts are a form of business record, which includes recognition by a witness of the document in question as the particular printout from the computer. Regarding such entries, most judges will judicially notice the validity and reliability of computers. If not, proof must be offered of the reliability and correctness of procedures used in obtaining the printout offered as an

If a declarant's state of mind is a fact in issue (declarant need not be a party to the litigation) evidence of his declarations relative to his state of mind is admissible. Declarations can be oral, written, or maybe inferred from conduct, for example, the use of signals.



# Tourism campaign in Bicolandia

LEGAZPI CITY - The regional office of the Department of Tourism (DOT) here has embarked on an aggressive promotional and marketing strategy to increase tourist arrivals in the region.

DOT Regional Director Pilar Hilario told We Forum that in 1988, the country played host to some 1,041,000 tourists who brought in \$1.3 billion in tourism receipts. At least 28 percent of these travellers visited the Bicol region.

Also in 1988, Hilario continued, the Bicol region accommodated 89,319 domestic and 4,056 foreign tourists.

Among the region's six provinces, Albay had the highest number of visitors, with 51,782 local tourists and 3,311 foreigners; as compared to Camarines Sur's 30,083 local tourists and 585 from abroad. Heavy traffic of tourists visiting Bicolandia starts from April to September in time for the region's traditional fiestas and other cultural celebrations such as the Penafrancia festival in Naga, Camarines

DOT records showed that from January to March of this year, a total of 18,048 tourists arrived, and 16,927 of these were domestic or local tourists. Among the foreigners who visited the region, Americans accounted for the highest number with 217 persons; West Germans, 181; Japanese, 141; and other nationalities, 197 tourists.

Mayon Volcano, the

world's most perfect cone volcano, remains the most frequented tourist attraction of Bicol. Mayon's conical symmetry makes her a very strong tourist attraction. Her fertile slopes and surrounding plains nurtured by abundant rainfall throughout the year makes the place where she sits a rich agricultural region.

But this great beauty also has tantrums. She is the most active volcano in the Philippines and has had periodic eruptions during the last three-and-a-half centuries. It appears on PHILVOCS (formerly COMVOL) records that the earliest eruption occurred about 1616, but her first eruption to be described at length was that of July 20, 1776, which lasted six days. The most violent and destructive eruption occurred on February 1, 1814. It was said to be preceded by local earthquakes the day before, continuing during the night and culminating in a violent outburst at eight in the morning.


During this eruption the areas surrounding Mayon were enveloped in ash showers while terrifying lightning discharges intermittently broke through dark clouds. The catastrophe left at least 1,200 people dead while severely damaging the town of Camalig and burying in tons of volcanic debris Cagsawa and Budiao. Half of Albay District and Guinobatan were laid in ruins. Only the belfry of the Cagsawa church remained

half-buried, a grim reminder of the fury of Mayon, a favorite tourist destination today.

Aside from its volcanic spectacle, Mayon is also the favorite of local and foreign mountaineers because of its thrilling but dangerous tracts and ravines. The first recorded Mayon climbers were two Catholic priests named Fr. Pedro Ferrer, O.S.F. and Fr. Esteban Solis, O.F.M. The two made the historic trek to Mayon's summit in 1592. Last May, DOT Region V sponsored the "Mayon Conquest '89" where several Filipino and foreign mountain climbers succeeded in "conquering" Mayon's crater. The project was started in 1976 and is now an annual crowddrawer in Bicol.

Another famous attraction in Albay is the "Great Sibidan Festival", an annual boat race sponsored by the DOT regional office. The festival coincides with the fiesta of Tabaco in honor of its patron saint, St. John the Baptist whose feast day falls on June 23-24. Tabaco is a flourishing town 24 kilometers north of this city and is noted for its scissor-making industry.

"Sibidan" is coined from the Bicol term sibidsibid, a small but light outrigged banca that may range from three to six meters long. Sibid-sibid is commonly used by small fishermen for speedy transport of light cargo. Some of these fishermen utilize sails when the wind permits an

easy and convenient travel.

This sports event, which is the local version of yacht-racing, is an elaborate display of force, strength, skill and endurance exhibited by muscular fishermen from the coastal barangays of the Bicol region.

The event has two categories: saragwanan (paddling) and paralayagan or sailing. In the saragwanan race, the daring participants use their own sagwan (paddle) to move the vessel. On the other hand, paralayagan will have to rely for its speed on the wind, and with only little effort in the use of the fishermen's sagwan.

In Camarines Sur, pilgrims and tourists converged in Naga City for the annual Penafrancia festivities. Every September, the image of the Our Lady of Penafrancia, ācknowledged Patroness of Bicolandia, is borne on the shoulders of the voyadores and brought to the Naga Metropolitan Cathedral for a nine-day novena. After the novena, the image is returned to the Basilica in a traditional fluvial procession along the Bicol River.

For nature lovers, scuba divers and wind surfers, the island province of Catanduanes offers a lot of unspoilt beaches. With the resumption of PAL's Manila-Virac and Leagzpi-Virac flight, Catanduanes experienced an increase in tourist arrivals from 340 in 1987 to 467 in 1988.

But the tourist industry in Bicol is also facing some challenges or problems.

Topping the list are the local weather disturbances that regularly occur in the region. Since Bicol is located within the typhoon belt, close to a dozen tropical cyclones visit the area and bring destruction not only to tourist facilities but to the region's economy as well. Often, PAL has been forced to cancel its flight to and from the region because of the erratic weather condition that made flying difficult

Other problems besetting

the industry are insufficient tourism promotional materials, limited research and development schemes, lack of foreign language-speaking frontliners dealing with tourists, and inadequate tourist services, among others.

Criminality and the raging insurgency war in the countryside are also considered negative factors.

However, a tourist who visited Catanduanes said of the insurgency war taking place in Bicol: "Tourists, at least, appear to have little to worry about. The povertystricken Philippines would be in even more trouble without tourist dollars, in addition to US aid and military installations. Also, the Communist insurgency (being waged by the NPA) is focused on military, police and political targets, and that's what makes all the news. So, most travellers to the region look at it this way: IFYOU'RE NOT WEARING UNIFORM, YOU'RE NOT IN ANY REAL DANGER."

State of Mind:

Mental condition. Intent, knowledge, malice, motive, design, competency, belief, assent, etc.

Emotional Condition. Anger, affection, ill will, fear, etc.

ments of past bodily condition. Admissibility is not restricted to exclamations made at the time an injury was inflicted.

A statement must be made contemporaneously, or nearly so, with the time of the relevant state of mind. Where the statement was made and who was present must also be shown.

A witness can testify as to his state of mind on a previous occasion. It would be inadmissible hearsay, however, for a third party to testify as to what the declarant told him his state of mind was on that previous occasion. 10.34.1. Proving Other Facts By State Of Mind Evidence:

A statement of memory or belief by an unavailable declarant cannot be used to prove a fact remembered or believed. A statement by an unavailable declarant, however, as to his intention to do something is admissible as evidence that he in fact did it, for example, that he revoked his will. A statement by "A", an unavailable declarant, that he was going to meet "B" in a certain place, can be used as circumstantial evidence to prove that "A" went to said place; it cannot be used as circumstantial evidence to prove that "B" went there.

The modern trend is to admit evidence

of the conduct and statement of a third party, indicating the state of mind of said third party, as circumstantial evidence in appropriate situations. Suppose, for example, that the issue is the competency of an individual. The conduct including statements of another, that is, a third party towards that individual can be shown, demonstrating that, by his (the third party's) conduct towards the individual whose competency is at issue, it is apparent that the third party regarded the said individual as a normal, competent person. From this circumstantial evidence, an inference of competency may be drawn. Obviously, a foundation of acquaintanceship and opportunity to observe must first be established.

## Foxholes in Zambo town

A REMOTE Zamboanga del Sur town that never knew war is now another Negros Occidental in the making, with families either building foxholes or leaving their homes in order to survive.

(Negros Occidental in recent months was the scene of mass evacuations from heavily militarized zones in the province. At least 300 children died from measles and diarrhea epidemics which broke out at the evacuation centers.)

Josefina parish (pop. 300,000), composed of 22 villages, is on the eastern boundary of Zamboanga del Sur. The mountain villages along the Mt. Nalindang Range also connect to Zamboanga del Norte and Misamis Occidental -- an interprovince transit point strategic not only for mountain

folk but even government soldiers and their arch-enemies, the New People's Army guerillas.

Josefina recently witnessed the influx of 25 refugee-families of the Subanen tribe from the villages of Namot and Gala in Tudela, Misamis Occidental.

The Subanen from Namot have been wandering the forests since July 1988 after 55th Infantry Brigade and Civilian Armed Forces Geographical Unit (CAFGU) members killed a tribesman, Melanio Jalalon, and burned their homes.

Josefina parish priest Felix Tigoy said it was only in March this year that the Namot Subanen chanced upon the Gala Subanen in the forests.

The Subanen from Gala have also been wandering the forests since January this year after tribesmen Pablo del Pilar, Sario and Emiliano Jalalon were shot dead allegedly by government troops.

The 96 Subanen men, women and children (many had died in the forests) arrived in Josefina hoping to rebuild their shattered lives, only to find that Josefina itself was bracing for war.

103rd Infantry Battalion Commander Col. Renato Garcia, in a "dialogue" with government, civic and religious leaders in the town, said that "Mrs. Aquino's total war policy against the insurgency will be accomplished in Josefina in 1990," two years earlier than 1992, which is the national target set by the government to crush the insurgency.

"We have men trained in Vietnam, we have mortars and helicopters, we have everything to defeat them (the NPA)," said Garcia.

As early as August, members of the 4th Infantry Battalion had forced residents of

## Big shopping mall rises in Mindanao

CEBU CITY -- One of the biggest, if not the biggest, shopping malls in Mindanao is rising in General Santos City, Cotabato, and is expected to give added bustle to the commercial activity there.

The shopping mall is the White Gold City, part of the massive chain of department stores owned by the Cebu-based Gaisano family.

Joseph Gaisano, president of White Gold, Inc. (Cebu), told Asian News & Features that White Gold City in General Santos City (formerly Dadiangas) stands on a five-hectare lot in a strategic area of the city.

"Construction of the shopping mall will be in three phases," Gaisano said. "The first phase which has just been completed started early last year and the second phase will be finished in September this year."

Gaisano also said that the Bank of Philippine Islands (BPI) has granted the Gaisano family a P100-million loan for the White Gold City project. The loan agreement was signed at the White Gold House Restaurant in Cebu City last week.

The signatories to the

Bagong Argao, Molave (four kilometers from Josefina) to build 50 shacks and 50 foxholes along a two-hectare piece of land for the soldiers' loan agreement were Joseph and Francisco Gaisano for White Gold City and Ricardo Balbido Jr., vice president of the BPI-Family Bank and Claro Reyes, head of the BPI regional branch in Mindanao, for the lending bank.

Phase one of White Gold City, which has already opened, is occupied by Gaisano Dadiangas, a modern department store complex.

Phases two and three will be occupied by other concessionaires.

When fully completed, the shopping mall will have additional department stores, a number of moviehouses, restaurants and other features found in modern shopping malls in Metro Manila. It will also have a spacious car park.

Aside from White Gold City in General Santos, the Gaisano family also owns and operates big department stores in Mindanao including those in Davao City, Mati, Davao; Cagayan de Oro City and Iligan City.

In the family's homebase in Cebu, there are six Gaisano superstores and one restaurant which is reputed to be one of the biggest in the Far East.

There are also Gaisano department store complexes in Iloilo City, Bacolod City, Tagbilaran City and Dumaguete City.

liberations of the 1986 Constitutional Commission support the Speaker's argument. In Sanidad vs. the Commission on Elections, Justice Ruperto Martin defined a referendum as "merely consultative in character. It is simply a means of assessing public reaction to

the given issues submitted to the people for their consideration.

This seems to agree with the rationale behind Section 16, which was explained by Commissioner Edmundo G. Garcia.

"[T]he new Constitution must...institutionalize people's participation and ensure consultation among the basic sectors at all levels of social, political and economic decision-making guaranteeing that the people have access to information necessary to make informed and responsible decisions.

Concretely the State must be mandated to make possible proper and adequate consultation mechanisms with the people, and the formulation and implementation of local, regional and national priorities, plans, programs and projects that affect the people's lives.

"It is again a recognition of the principle that people must be consulted especially regarding decisions which will affect their lives. Very often it is the people who are very close to the problem; that is why they can tell what the problem is, and perhaps the solution lies along the same lines. The proper function of the legislature in this regard would be to try to formulate mechanisms of consultation that would ensure talking with the people and finding out their ideas. This should be done regularly and directly so that the State or the planning agencies will be able to harness the participation of the people in an institutional manner." (AE)

## A surprise from CSC

Actually, the column was about my unpleasant experience at the Register of Deeds office in Quezon City last June 5, 1989 involving one of the personnel, a certain "Mr. Pedro."

It turned out that "Mr. Pedro" is Concepcion P. Pobre of the same office who had claimed, after the CSC asked for his side, that as far as he could remember, he attended to my papers "expeditiously and cheerfully."

I wonder if Mr. Pobre even remembers me, considering that his office is a beehive of activities and a lot of clients pass through his desk daily.

The reason Mr. Pobre-or Mr. Pedrogave as the basis for his "cheerful and expeditious" service was that he has never been charged administratively in his 20 years of service in the government.



I guess it's my word against Mr. Pobre's.

I have never been accused of concocting an incident that would put down anyone, either.

Be that as it may, I am glad that the issue has reached the Civil Service Commission and, more importantly, that it has acted voluntarily on it.

The gesture of the Commission, particularly of the DART project team, should restore the people's faith on their public servants, notwithstanding the likes of Mr. Pobre. The Commission's action should serve as a warning to the thousands of government employes to be more efficient and effective in dealing with the taxpayers.

To Chairman Sto. Tomas and Ms. Santos, our thanks and congratulations for taking up the issue we raised. You are indeed public officials worthy of your position. May your tribe increase.





## \* More brownouts in Metro Manila

MORE BROWNOUTS will continue to plague Metro Manilans because of the lack of power supplied to the Meralco, according to the National Power Corporation.

The power outage is due to the "tripping" of transmission lines in the Makiling-Los Banos area which occured the other day and last Sept. 28.

Napocor authorities said that power supply may be normalized as soon as the system is stabilized in the Mak-Ban lines. At present Napocor can only supply 119 megawatts to Metro Manila and that 200 megawatts are still needed to meet the power needs of the Metropolis, they added.

The Napocor and Meralco also yesterday implemented a so-called "rotation brownout" which would last for two hours a day for residential and commercial areas until normal supply is restored.

## \* ConCom delegate twits Mitra

THE PROPOSAL of Speaker Ramon V. Mitra for the holding of a referendum to determine the preference of the people on the US bases question will amount to an amendment of the 1987 Constitution, former Constitutional Commissioner Jose N. Nolledo said yesterday.

Nolledo, who was also a delegate to the 1971 Constitutional Convention (representing Mitra's province, Palawan), said: "Unreflected and erroneous opinions on the fundamental law have habitually emanated from the Office of the Speaker to my great dismay."

Twitting Mitra for allegedly misreading the Charter, particularly Section 25, Article XVIII of the 1987 Constitution, Nolledo pointed out that the position taken by Senate President Jovito R. Salonga is correct because it is in accordance with Constitutional, moral and legal grounds.

Salonga had said he was in favor of a referendum but at a proper time or after the Senate shall have acted on a treaty in accordance with the Constitution. His position was supported by majority of the senators.

Mitra, on the other hand, together with President Aquino and other congressmen, is for a referendum first pefore the Senate can act on any new treaty involving the American military facilities here. (Omer Almenario)

## Laurel: FM return could unite people

KEEPING THE remains of the late ousted President Marcos outside the country will only exacerbate the present state of division and fragmentation among Filipinos, Vice President Salvador Laurel said yesterday.



Laurel, who met with top Armed Forces officials in a closed-door conference, reminded the military of "their crucial role in this critical period."

He added: "The return of Marcos will foster political stability and will help bind the nation's wounds."

He also cautioned Marcos loyalists to take all peaceful means to convince President Aquino to reverse her stand banning the homecoming of Marcos's remains, as well as that of the immediate family members.

He added:

"I know that tension is rising because sometimes it becomes hard what they are doing to us-that they don't want to allow President Marcos to come home. We know that is wrong and our tempers are quick to rise. That shouldn't be. We left the Philippines and my father gave up his life so that no Filipino would get hurt. Please don't change that. Until the end, we should not violate the law. We will always pursue our end in as peaceful a manner as possible."

Meanwhile, Marcos sup-porter PC Maj. Reynaldo Cabauatan said yesterday that a peace plan should be devised and approved between the Marcos loyalists and the Aquino administration to prevent any trouble in case the remains of Mr. Marcos are brought home.

Cabauatan said the agreement should be made public to make sure that the Marcos supporters will keep their word and not cause any trouble.
