Snap polls or none?

HY CAN'T Malacanang say what it means, and mean what it says on the snap polls?

Last January 28, the pro-Marcos-turned-pro-Cory Bulletin reported that the President had said "she will leave it to the people to decide in a plebiscite whether there should be a snap presidential election... Earlier, Mrs. Aquino had told presidential aspirants to wait for the May 1992 presidential election as provided by the Constitution."

Another paper, the Inquirer, said it differently: "President Aquino yesterday said she was open to the proposal to advance the May 1992 national elections to November 1991... However, Presidential Spokesman Adolfo Azcuna later cautioned the public against

President, according to
Azcuna, "did not mean she
was in favor of calling a snap
presidential election."

Then on January 30, the President said before TV cameras that she's in favor of resetting the May 1992 local polls for a later date but not the national elections, either for an earlier or later date.

Which is which now?

There would have been no confusion if only the President and her spokesman were to the point. On this score, Doy Laurel fares much better. He says there

ought to be snap presidential polls soonest, and he says it clearly.

SINCE MAY 1989

The Vice President has actually been clamoring for snap elections since May 21 last year, during the revival of the Nacionalista Party. The NPs then passed a covering resolution addressed to Ms. Aquino, who immediately turned it down. Said she: "Unang-una, 'yung pagtatawag ng snap election, hindi basta-basta ginagawa 'yon. Noong panahon ni Marcos, dahil parliamentary form of government pa tayo noon, he was empowered to call for snap elections."

On this, we said that while her decision may be right, her reason wasn't. "It was only on paper that the Marcos government was parliamentary... In actuality, it was a dictatorship, plain and shameful. Thus, if Marcos could call for a snap election in February 1986, as he did, it was because he was the Dictator, and not even the Supreme Court could say the election was unconstitutional..." (Editorial report, May 26-28, 1989)

To the NPs, both Cory's decision and reason were wrong. The party's EVP and 1986 Con-Com commissioner Blas Ople said it's constitutionally possible to hold snap elections, while Sen. Juan Ponce Enrile claimed that Cory's position was no different from Marcos's before 1986. "Marcos said he had a contract with the people, and yet Marcos gave way to the clamor of the

people," declared Enrile. Should Ms. Aquino decide to hold snap elections, he went on, she'll be also putting to rest the undying issue of her presidency's legitimacy.

But should the President do otherwise, the NPs promised to avail themselves of the system of initiative and referendum under Sec. 32, Art. VI, of the Constitution. This section provides that 10 percent of the total number of registered voters in a given district may, in a written petition, directly propose the holding of a referendum on such matters as snap elections.

The NPs bragged that they could easily obtain 2.6 million signatures. It has turned out to be an empty boast.

ANOTHER CALL

The possibility of holding snap polls cropped up again after the December coup. Many saw it as a last warning by the fractious military to Cory to step down. The unexpected visit of such Bush emissaries as Robert Gates fueled speculations that the special elections will be held late this year.

Four senators, among them the President's brother-in-law, then filed a resolution setting the polls late next year, only six months before the regular elections.

Soon everybody, including our children, was giving a piece of his mind, so much so that at this writing the brouhaha has become a babel of noises.

Politics is really a fever in

the blood of us Pinoys. It's our way of life. We're probably the most "politicized" people on the face of this planet.

Levity aside, this snappoll issue is something the President can't just brush aside. Personally, we favor the holding of presidential elections the soonest, arguing that there's no sense in prolonging the people's misery under the present dispensation. Ms. Aquino has had her chances to prove her worth as President. With all due respect to her, we submit she has failed. Broken are most of her pre-election promises, which we discussed in detail in our editorial report "Cory's broken promises" (June 2-4, 1989).

TOO LONG

It's said that four years is too short a time for a good president. Conversely, the same span of time is already too long for a bad executive, and six years (which is President Aquino's term) would be eternity.

She may have the best of intentions but this, it goes without saying, isn't enough. It's no excuse for her to say hers is not a government of saints and holy angels.

Like the NPs, this paper believes that the holding of snap polls is constitutionally possible. Admittedly, it will be expensive (which undertaking is not, nowadays?) but that's the price our people have to pay to get the government they deserve.

And they deserve better.

The Cordillera: Now, what?

government's package of autonomy for the Cordillera has been ancient province of Ifugao.

AGUIO CITY - It is final and irrevocable. The Manila crushed in all provinces in the region and the city of Baguio except in the

The palace's lame explanation that the recent plebiscite was a triumph of democratic processes could not hide the fact that after spending at least P38 million in cash, the administration has found itself swallowing the bitter pill of rejection, spurned by a people it has failed to understand.

As heated arguments and impassioned speeches die down, Eddie Aguilar, veteran radioman, Baguio councilor and a key campaigner for rejection sums up the result of the plebiscite with a one liner: "We are back to being friends." It is the understatement of the day. For there is more than meets the eye to the plebiscite result than just betting on one side against the other like in a cocklight.

THE VICTORS

Traditional politicans like former Baguio mayor Luis Lardizabal, former Benguet governor Ben Palispis, Congressman Samuel Dangwa and former Benguet Congressman Andres Cosalan have proven one point. In any political contest in that upland region, they are still a strong force to reckon with. Congressman Dangwa now says that autonomy lost because framers of the rejected organic act did not consult the people. They want selfrule, but the type of self-rule they themselves determine, not something imposed on

Beyond the rhetoric, however, is the fact that the chief victors in the plebiscite are the giant mining companies in Benguet. The autonomy act threatened their monopoly of economic power in the area. There are provisions turning power over the region's natural wealth to autonomous government. As such, the mines will be forced to play an entirely new ball game outside of Manila where political clout

is presently concentrated. They will be forced to pay a minimum wage scale not lower than the poverty line. They will be forced to buy outside or plant and grow their own trees for use in their underground mining operations. And they will be forced to share a bigger bulk of their taxes with the locals.

They won that one, no doubt about it.

Big land owners in Baguio City have likewise won the plebiscite. They could now be assured that no urban land reform will come their way and threaten their positions of privilege in a land-scarce city where the most expensive pieces of real property are highest in the whole country.

The communist underground also shares in that victory because it can now rightfully claim that instituting radical reforms through parliamentary struggle is an exercise in futility and only an armed insurrection could accomplish the job.

Fr. Conrado Balweg and his Cordillera People's Liberation Army could also claim victory especially when a landslide no vote was evident in territories where he and his Cordillera Bodong Administration are known to be of influence. This could boost his faltering credibility at a time when he is being portrayed as the head of the biggest Low Intensity Conflict (LIC) force in the Cordilleras.

The biggest victor of them all is the Manila government which could now stop worrying about where it will borrow the promised P1.5 billion national government subsidy a year for the next five years in development funds for an autonomous region. It is also assured of the power to determine the region's share from the national coffers and dictate programs and policies affecting the area.

THE LOSERS

Incumbent political leaders who threw their support to the ratification campaign like Congressmen Honorato Aquino, Rodolfo Bernardez and Victor Dominguez are already written off by their political opponents in any future political exercise. In their league are the Bugnosen brothers, Jimmy as mayor of Baguio and Andy as governor of Benguet.

The number one casualty is the autonomy movement, assesses Abrino Aydinan, chief architect of the organic act as chairman of the Cordillera Regional Consultative Commission subsidized by the national government to prepare the original draft.

"It is a big blow to the au-

tonomy movement, perhaps a crippling one," Aydinan tells this writer. "And it is bound to further fan armed insurrection in the region's hinterland."

Aydinan does not see any opportunity in the next few years for a new draft acceptable by a majority of the Cordillerans to be written and resubmitted to Congress and again be thrown back for ratification.

"It has been an opportunity missed," adds Reynaldo Bautista, president of the University of Baguio, the second largest educational institution in the region. "We could have established a legal framework on which the region could be truly unified and for fundamental changes to be introduced."

In the field of education

alone, an autonomous regional government could initiate the needed reforms in educational system where the Department of Education in Manila has failed, the head of a national organization of private educational institutions laments. As one of the most vocal advocates of ratification, Bautista has offered to serve without pay in the proposed regional government to set into motion a restructuring of the educational system in the area.

BACK TO SOUARE ONE

Even those who campaigned for rejection are beginning to realize it has been a hollow victory. Eddie Aguilar understood it right when he said, we are back to being friends. No change for better or for worse. Just a simple perpetuation of the status quo.

Status quo means that for the year 1990, the Cordilleras receives the smallest share in funds for infrastructure projects in comparison to 12 other administrative regions in the country.

And if President Aquino does not change her mind, the Cordilleras with the exception of Ifugao, will fall under an administrative region under Executive Order No. 220, an agreement inked between the Cory government and Fr. Balweg as a condition for peace in the highlands.

The central governing body with very limited powers is the Cordillera Executive Board headed by an executive director with governors of Abra, Mt. Province, Kalinga-Apayao, Benguet and the mayor of Baguio as key members. The Cordillera Bodong Administration of which Balweg is executive director will stay as a parallel government in areas where the bodong or peace pact is practiced.

Regional policy making will remain in the hands of

the Cordillera Regional Assembly whose members were appointed to serve in an interim capacity. Line government agencies of the Cordillera Administrative Region will function directly under their central offices in

OUO VADIS CORDILLERAS?

The plebiscite resulted not in an autonomous region but in an anomalous situation where just the province of Ifugao is entitled to an autonomous government while the rest will have to stay as parts of a reduced administrative region. How that anomaly will be corrected still beats people in the central government. For if Ifugao is granted autonomy, it will be having two governors, one regional and one provincial, two lawmaking bodies, six regional line agencies of government and P1.5 billion yearly subsidey if the national government lives up to its promise.

While the administrative region composed of the other provinces and Baguio will enjoy no subsidy, they will have to make do with their regular allocations. Baguio and Benguet will have nothing to worry about asking for national government help to run their affairs because they generate sufficient local revenues. Abra, Kalinga-Apayao and Mt. Province

resource rich but economically poor, will have to make do with any additional funds doled out by the central government for whatever economic, social and infrastructure projects the latter wants to subsidize.

In that kind of situation, the grounds on which rebellion grows and spreads, get more fertile as the desperate situation of the poverty stricken rural population sees no hope of getting saved.

What happens next will only be the subject of speculation.

LOOKING AT THE FACTS On the allegations vs Fr. Cullen

MODERN DAY prophets are few and far between. They are dangerous men and women and like those before them. Amos. Jeremiah, John the Baptist and Jesus Christ Himself. They were all marked for vilification, stoning and death. In Olongapo, Father Shay Cullen has had his share of stones and curses over the years for his work among the women and children protesting their exploitation and dehumanization. Now death threats after the legal defeat of his detractors from Olongapo's sleazy hotels and clubs. In recent weeks the evidence presented in the packed and stuffy court room of the Commission on Immigration and Deportation (CID) revealed the shoddy and inept frameup that was supposed to discredit him and his work before the world. The fabrications were uncouth and fantastic enough to catch the attention of a scandalhungry media but the outpouring of solidarity by thousands of supportera and now the letter of support from the 110 Bishops of the Philippines has vindicated Father Cullen and badly backfired on the perpetrators. The CID will be only too happy to get rid of this scorpion of a case after the prosecutor Renato Mabola brought ridicule and derision to the Commission by trying to claim that Fr. Cullen wrote news reports damaging to himself and that foreigners had lesser human rights than Filipinos. Filipinos abroad will be outraged because they might be all the more treated as

The CID hearing officer Atty. Ledesma after allowing Atty. Sergio Cruz, the counsel of Fr. Cullen to argue his motion to dismiss the false charges stopped all proceedings and cancelled future ones and said he had heard enough to decide the merits of the motion to dismiss. That was some victory for Fr. Shay Cullen after he was denied the chance to present his side to the court and the public. It is also a bitter disappointment to those who cooked up this charade. Some of

the media kept repeating the false charges in their reports without asking the prosecutor if there was evidence to support them. Had they looked they would have found nothing. There is none. Then the story would have been PRIEST FRAMED BY CID?

No reporter got that angle. Many including the wire services just kept repeating the false charges; they never sent a reporter to look for the so-called evidence. I decided that this case deserved a bit of investigative journalism and a touch of personal reflection on the events surrounding the charges and arrest order for Father Shay Cullen, Columban Missionary. A visit to the Preda Center in Olongapo and talking with both Government officials and other people who know Fr. Cullen shows this case to be a cheap farce and a disgusting display of injustice. In the case of Father Shay Cullen, did they just presume the priest was guilty without a further thought or investigative question? Let's look at the

> THE EVIDENCE EXONERATING FR. CULLEN

The evidence presented by Fr. Shay's counsel at the CID hearing was sufficient to show that the false complaints were instigated by bar and club owners from Olongapo and without the benefit of due process, or listening to what Father Cullen could say in his defense. Charges were immediately typed and filed, then released to the press on November 28, 1989. If we study the court documents, we should have seen that there were no affidavits or other documentary evidence to back up the charges. Many of the false charges stemmed from the year-old incidents, points of conflict between the Preda Child Center where the priest works and the mayor of Olongapo and his mother. The affidavits supporting the false charges were made up later when the CID

hearing officer Atty.
Ledesma ordered that Fr.
Cullen's counsel Atty. Sergio Cruz be given the affidavits. After weeks of delay, three were produced, two of them had dates showing that they were made after the charges were filed. The other was made the previous April for some other purpose.

What was the purpose of this ham-fisted attempt to frame up a well-known Catholic priest who has been prophetic in his work, is a writer and poet and internationally known as a defender of women's and children's rights? Who would likely benefit from such a contrived injustice? What could his detractors gain by falsely accusing him of land grabbing, of being an enemy of the people because he wrote about the sexual abuse of women and children and had been irresponsible in taking care of the drug dependents and street children in his care. Other charges of throwing dead bodies out of graves and sponsoring lewd shows are too preposterous for intelligent Filipinos to consider. They should be treated with the contempt that they deserve. Whoever prepared these inane complaints had little respect for the education and intelligence of the Filipino and as such they are insulting.

These are the facts we gathered:

1. The Department of Environment and Natural Resources stood by its lease contract with the Preda Center, where Fr. Cullen works. It expires in the year 2008.

2. The priest is writing irresponsibly and defaming the city of Olongapo, they claim. But the priest has given his life to save the people from every kind of exploitation and to protest the injustice of the cruel system. His articles, if we take the time to read them, show profound respect and a hunger for justice for the poor. Besides, the evils of Olongapo are well documented elsewhere but they are not being sued.

3. He sponsored a lewd show at the Marmont hotel in 1981, they falsely say. I have learned from the records that Fr. Cullen filed a suit against the organizers of that event because they used the name of Preda without permission to get a charity permit and they claimed it was a fashion show which was granted a license by Mayor Richard Gordon, Gordon is blaming the priest for his own mistakes. The son of the former congressman promoted the show, it seems.

4. Mismanaging donations to the Foundation has not been supported by any single incident and I have checked with the government agencies monitoring Preda's finances and there has not been a single complaint in the 14 years since Preda Center began services to the drug dependents and street children of Olongapo and elsewhere. The place is well and professionally run and strict bookkeeping is the order of the day by a dedicated staff.

5. The detractors claim that the priest desecrated a grave. During my research I found that the mayor's mother allegedly wanted to bury her godson on the Preda land beside the Preda driveway. She claimed it was hers and sent bulldozers at night to level all that was there. The Preda objected and angered the political family who apparently bore a grudge against the priest ever since. If you visit Preda you will see that the politicians got their

6. As for mistreating a resident at the Preda Center, I searched for the name of the patient in the files of the Dangerous Drugs Board in Manila and there was none. This bears out the account of the Preda staffers who say that such a patient came and stayed for screening only and then left. There was no hard work during his brief stay as detractors claim and the poor at Preda are supported free of charge. The well-off only pay for food.

7. There is an affidavit

of a woman who claims her informally adopted child Ching Castro was illegally brought to the Preda Center. The street children at Preda say Ching came once a month for a few hours to eat, sleep and go away. He has a record as a street child with the Department of Social Welfare. Based on a newspaper story wherein Ching told Mike McIntyre of the San Diego Union he had no mother now but she once worked in a bar and said he was shaved off by Mayor Gordon's bodyguards and jailed by them. The boy was

for sex and drug dealers selling in night clubs and the authorities raking in the money. We, so proud to be Filipino sit around doing so little. When a prophet stands among us and confronts the devil, we turn our backs and presume him guilty. We Filipinos cannot deny the truth that we bring a lot of our poverty and corruption on ourselves by bowing to our dominating masters. We are gullible, so quick to believe the accusations of our oppressors and helping them stone our priests

in Preda the day McIntyre dropped by, according to McIntyre himself. Later that night he was found by McIntyre in the jail. Many articles critical of Olongapo are wrongly attributed to Fr. Cullen.

I could find no basis to the charges and all the official documents bear out the rebuttal of Father Shav Cullen. There is no shred of evidence to back up the allegations but there is evidence to show that it was a blundering frame-up that did not come off. Perhaps that is why some people say we Filipinos deserve what we get, that is why our children go on being sold. raped and sex-abused by tourists and American sailors before our eyes. A baby of 18 months getting gonorrhea, young women sold to sex dens here and abroad, small children sold

and prophets. We should be stoned ourselves for our stupidity and self-defeating attitude. To be true Filipinos we have to stand and fight and answer back the oppressors with the truth or we will never see justice in this land. Fr. Cullen, a Columban Missionary, an order dedicated to being in solidarity with the poor and working for justice and saving the ecology that our rich destory came here and gave his life for us by helping the victims of drugs and sex abuse. The least we can do now is stand with our priests and bishops and join Fr. Shay Cullen in fighting the immorality and the evils that plague our country especially that major source of the poison. the Olongapo City night club industry and the US military bases, which it serves.

Filipino people versus whose case: Olongapo crimes or Fr. Shay Cullen?

AW ENFORCERS and crime busters have been going after a defender of the abused in Olongapo. In so doing, they are dangerously abetting the social poisons emanating from crimes like prostitution, drug and child abuse, making these more degeneratively vicious to Filipino women and children they victimize.

This is the case of the harassment that Irish priest Fr. Shay O. Cullen has been experiencing from the Commission on Immigration and Deportation (CID) and the Olongapo City officials. Cullen, who has been described as "perhaps more Filipino than his Filipino adversaries in government", bears witness to extensive sex. drug and gambling scandals abusing countless hapless Filipino women and minors. His tale also bespeaks of rare courage that has stood up against these injustices withstanding a decade of harassment and intimidation.

For more than two decades, this Irish clergyman had been doing mission work in Olongapo City. He built up the PREDA, principally, a rehabilitation center, for victims of drug and sex abuse in Olongapo.

Unabated and wanton sex, drug and gambling scandals involving more and more women and children around the Subic Naval Base have compelled Cullen to speak up and write about them for the past 10 years in several newspapers like the We Forum, Malaya and the Philippine Daily Inquirer.

The freelance writer and Inquirer columnist has counseled countless of women who were promised marriages only to be abandoned, beaten and bruised by the American servicemen. He has listened endlessly to stories of ladies shipped to Hongkong without ever knowing when they will ever see their families again. He has seen 18-month-old babies with gonorrhea and little children at 9 and eleven being

peddled to pedophiles.

The 47-year old cleric assesses that these evils have threatened "the life of the Filipino family, the traditional values of the home, the sanctity of marriage, the respect and love for children" in Olongapo. Cullen is also actively campaigning for the removal of the US military bases which he claims promote prostitution, drug addiction and child abuse in Olongapo. He adds that very recently, he and some other writers, were told by their sources that the US Naval authorities are aware that certain drug dealings going on in several Olongapo night clubs involve some of their

Cullen claims that powerfull forces are trying to silence him. The latest harassment he has received involves charges filed with the CID on the basis of complaints of six Olongapo residents. Cullen says he has not been informed of the charges against him or of the identity of the complainants, and was not given the chance to file a counteraffidavit. The cleric also curiously notes that the case against him was released to the media on the very same date of his alleged order of arrest

Cullen asserts that the charges against him are "baseless, false and malicious and that the prosecutor has conspired with (his complainants) to do the most damage and discredit me personally and the work I do." He adds that "it's a form of intimidation, prior censorship, and an attack on press freedom."

Cullen also asserts that

the reason behind this intimidation involves the vested interests of bar and night club owners, prostitution and drug syndicates. He says that his exposes of how young lives are being destroyed in Olongapo has put a threat in the incomes of these groups, since public opinion will eventually compel the US Navy to ban minors from these dens. He says that certain owners and politicians who give them protection have in effect become accessories to crime involving illegal drugs.

Cullen also adds that he has angered some people because he has helped children file charges against American servicemen who have sexually abused them and that there are now two Americans facing charges in court. He has also exposed trafficking of women to Hongkong being escorted by US servicemen. He claims one syndicate has been organized by a former American serviceman now in the custody of the

CID.

A month before the December scheduled talks on the bases, some 17 Olongapo City officials have filed a petition with the CID demanding the deportation of Cullen. They claimed that he was "an undesirable alien and an enemy of the Filipino people." Weeks before the filing of the petition, Cullen testified before a Senate Committee hearing on the US military bases.

But Cullen relates that these series of attempts to deport him began way back in 1982 when he wrote an expose for the We Forum (July 17-20 and September 24-26, 1982) involving US serviceman Petty Chief Daniel Dougherty. The dozen youngsters, victimized by the prostitution ring led by Dougherty, admitted to have been forced or lured into prostitution and they were found to be ill of acute venereal diseases (VD) including the recurrent Herpes genitalis. Dougherty

was allowed to escape the country through the connivance of some City officials and US Admiral Richard Dunlevy, Cullen recalls. The other Filipino pimps with Dougherty also went scotfree after posting bail. Meanwhile, pressure was exerted to silence Cullen and he was accused of tipping off Dougherty and maligning the integrity of Olongapo children and Mayor Gordon. It would be recalled that city and Base authorities have long hidden from the media exposes of such crimes. At that time, he also incurred the ire of some City officials when Cullen opposed the demolition of a fishing village and destruction of some community projects to give way for putting up a beer garden owned by a local offi-

The Missionary Society of St. Columban asserts in a statement that Fr. Cullen is "legally and morally bound to report and prevent"... "the abuses to women and children. The statement further reads that the charges against Cullen "is an attempt to stifle free speech and cover up gross immoral-

ity that is tearing apart the spiritual lives of the people especially the youth who turn to drugs to forget their problems. Fr. Cullen and the PREDA Center has taken a stand against this and his work is prophetic and an act of Christian witness for Faith and morals."

Last November, when the Olongapo City officials filed a petition for Cullen's deportation, 23 Bataan and Zambales priests also rushed to his defense. In a joint statement countering the charges against Cullen, they said he was "a priest of good standing in our diocese who has been denouncing the moral evils that beset Olongapo."

More recently, after Cullen addressed its 2nd National Congress last January 27, the Philippine Movement for Press Freedom (PMPF) promised to defend the Irish priest's right to expose truths. "The people's freedom to know is more important than any public official's hypocrisy and false sense of dignity," said Atty. Ricardo Valmonte, reelected president of the nationwide media alliance.

Why not import rain?

T IS now official. This rice-producing country will import 200,000 metric tons of rice to make up for the shortage of the staple caused by the drought, according to the Department of Agriculture and Food. The volume of the projected importation is speculated at this time. DAF headman Senen Bacani says it may well go beyond the initial 200,000 metric tons, depending on how long the drought will last and the future increase in damage to the present crops. With the dry spell expected to last until May at the earliest, the next few months may prove crucial to the nation in terms of the staple's availability. Thus the need for importation.

The effect of the drought is actually manifold. Right now, the country is trying to come up with a belt-tightening plan, in cooperation with the International Monetary Fund geared to fight the inflation which continues to increase at an alarming rate due to the drought that has reduced rice output and several other factors. Being seriously contemplated are two complementing measures: increase taxes on liquor, tobacco and soft drinks, and a drastic cut in public spending which naturally includes government hiring. (If the Aquino government is sincere, why not fire the 200 undersecretaries and assistant secretaries who do nothing but exacerbate the bureaucratic red tape and who are costing the government some P200 million annually? Since they will not resign from their positions despite Mrs. Aquino's call for voluntary resignation, no other recourse remains but to fire them).

It is not actually Bacani's fault that six palay-producing regions have been hit by the drought. If one must look for culprits, nobody is to blame for this sorry mess but the government itself who cannot summon enough political will to stop all kinds of logging that has depleted the country's forests and astronomically enriched a few greedy concessionaires and loggers in connivance with presidential relatives and the congressional leadership. That he is trying to avoid a repetition of this proposed importation next year is laudable, but his efforts might not prove rewarding due to circumstances beyond control. He may be granted all the money he needs in fertilizer subsidy to raise this year's palay output and institute short-term measures like crop production to temporarily stop-gap the farmers' plight and prod the National Irrigation Administration into building more irrigation systems and repairing or renovating old existing ones. But as long as forest destruction continues with government tolerance, all his efforts will come to no avail. The extent of ecological destruction has, in fact, reached such alarming proportions that a concerned director of the Department of Environment and Natural Resources has recommended the blowing up of bridges leading to the remaining virgin forests to spare them from the loggers. If nothing is done by the state, he warns, the remaining 988,000 hectares of virgin forests will be lost before the decade is over and some unbelievably greedy congressmen will become if they are not yet billionaires.

In desperation, someone proposed several days before that it might not be such a bad idea if we pray for rain and he cited some instances where prayers have actually worked wonders. And about two or three weeks ago, the government had sought the assistance of giant American Air Force planes based at Clark in Pampanga for some cloud-seeding operations to induce rain. This was to complement the Philippine Air Force's own brave efforts several days before. Sad to say that both ploys did not work sufficiently to relieve the drought. Perhaps in answer to the prayers and the cloud-seeding operations, some puny drizzles fell everywhere but if they fell anywhere near the La Mesa or Angat, they were not enough to raise the water level in the dams. So what is left for the inept government to do?

Here's a bright idea that the Cabinet has not thought of yet: Since the administration is in an importing mood, why not import rain?





Science

For the past few years, the Department of Science and Technology had been begging for additional appropriation. Their appeals fall on deaf ears. That is, the Congress we have today — lovers of UZI, Pajeros, buko and the likes of Jun de Guzman.

That neglect of science and adoration of the frivolous reflect on our country today. Corruption, unemployment, high prices, insurgency, crimes, series of coups.

My visit to the top of the Film Center building is also momentous. I had a good bird's eye view of the vast cluster of squatter hovels right next to the pride of Imelda's palaces by the Bay. The Cultural Center, Folk Arts, Convention Center, Philippine Plaza Hotel, PNB, GSIS. Yes, billions and billions of pesos to build those beautiful buildings. But next to them are the hovels of dirt, disease, poverty and crime.



Wish Don Claro were alive



TLR Malalapitan para sa puhunan

MALAKING TULONG sa malifiit na negosyante sa Metro Manila ang isang programa sa pagpapautang ng Technology and Livelihood Resource Center (TLRC). Hindi lamang nito nilulutas ang suliranin sa paghahanap ng puhunan, kundi nakatulong pa rin ito sa paglutas ng kawalan ng hanapbuhay para sa ilang grupo ng mga residente.

Ang TLRC, sa ilalim ng kanilang Urban Livelihood Financing Program (ULFP), ay may iba't ibang programa ng pagpapautang gaya ng Enterprise Development Financing Scheme (EDFS), Socialized Credit Scheme (SCS), Industrial Sewing Machine Financing Program (ISMFP) at iba pa. Ang mga ito ay kagyat na malalapitan ng mga nagsisikap o matatagumpay na maliliit na negosyante, o maging ng mga nagbabalak pa lamang na maging entreprenor sa metropolis.

Inilunsad ng TLRC ang ULFP upang sumuporta sa lahat ng uri ng mga proyektong pangkabuhayan at pagkakakitaan sa Metro Manila. Ang mga proyektong ito ay matatagpuan sa mga mahihirap na lugar sa metropolis, ang rehiyong may pinakamataas na bilang ng mga walang hanapbuhay, na tinatayang nasa 18.6 porsiyento o 2.9 milyong tao.

Sinabi ni Manuel Lopez, assistant managing director ng ULFP, na ang ahensiyang ito ay tumutulong sa pagpapaunlad ng maliliit na negosyo sa pagpapautang ng mga puhunan at pagpapalaganap ng pangkalahatang pagbabago sa pananaw ng mga mangungutang sa pamamagitan ng pagmumulat sa kanilang mga responsibilidad.

Samantala, sa mga programang pampinansiya ng ULFP, ang EDFS ang itinuturing na pinakahaligi. Ayon nga kay Rubuena Angeles ng Central Bank Review: "Ang EDFS ang isa sa mga institusyong sumasagot sa pangangailangan sa pondo para sumuporta sa maliliit na negosyo, na walang pagkakataong makautang sa mga tradisyunal na institusyong pampinansiya.'



Gov't urged to review military reward system

THE KILUSANG Bagong Lipunan (KBL) yesterday urged the government to review its military reward system for the capture of alleged coup plotters and rid it of features "abetting simulated arrests, commercializing loyalty and perverting the concept of good citizenship."

Former Speaker Nicanor E. Yniguez, said there have been mounting complaints that the system, involving millions of pesos, appears to be "vulnerable to scams among the pursuers them-selves."

Earlier, in Congress, KBL Reps. Rodolfo B. Albano (Isabela) and Salvador Escudero III (Sorsogon) had raised doubts on the wisdom of the reward system, branding it as "act of desperation". a form of "bribery" and similar denunciations.

1. Unduly substitutes the soldiers' duty to accomplish his mission, reward or no reward, ushering in the possibility that, although they are about to capture their quarry, they would not do it until a reward is offered for their feat.



He also deplored that while the national leadership had called for a "moratorium on coup talks to relieve the people of coup jitters, the government's own reward system and its escalating amounts only fuel more coup jitters."

The KBL head assured that the best foil against future coups are reforms which reformist soldiers themselves have been demanding as conditions for reconciliation and for which they installed Mrs. Aquino into power through February 1986 EDSA power grab.

US opposes WB loan to RP gov't

THE UNITED States virtually blocked approval of a \$390 million World Bank-International Monetary Fund loan to the Philippine government, Finance Secretarydesignate Jesus Estanislao disclosed yesterday.

In an ambush interview with Malacanang newsmen, Estanislao said he had already expressed his protest over the US action in a letter to American Ambassador to the Philippines Nicholas

According to Estanislao, the World Bank had proposed the loan package in an addendum to the Memorandum of Economic Policy, giving the Philippines the "biggest amount of loan thus

The United States abstained from voting over the package for "reasons that are only known to them," Estanislao said. "I told Ambassador Platt this is a very bad signalat avery bad time. And they were complaining on privatization and also some things which we are already doing. And so I sent a letter of protest to Ambassador Platt." Estanislao said.

According to him, the board of directors of the

World Bank voted in favor of the loan but the US abstained from making any vote. "This is the second time they have done that. In the financial sector loan which I also participated in negotiating, they also abstained. Fortunately, all of the other countries voted for the Philippines," Estanislao said.

When asked if the abstentions were related to the forthcoming talks on the US bases, Estanislao replied: "I do not know but certainly, I mind it very much that they are playing around with our economic policies and our economic programs."

When the new Finance Secretary was reminded of the recent US Congressional cut on their pledges, Estanislao said: "I am sure they are sending certain signals. I do not like those signals and if they are trying to deliver a message, certainly that is not the appropriate way of delivering a message."
