Bookie protectors

This afternoon a number of police and military vice squads will once more troop to the San Lazaro race track not to beef up the hippodrome's drive against bookie operators but to make "patong" (protection money) from the numerous bet collectors operating illegally in the area.

These "protectors" have been reportedly receiving fat bonuses from bookie operators who are giving the hippodrome management a run for its money, collection and profit-wise, my

The clandestine (kuno) bookie operation have not only been eating up the hippodrome's collections that run into millions per racing day but have been allegedly "fixing races" to the prejudiced of the thousands of race afficionados.

One classic example of a fixed race, my informant revealed, involved an outstanding horse called "Whisk Claire". This horse which is known for its terrific speed and stamina reportedly lost to a much inferior breed after a bigtime bookie operator "fixed" the horse' jockey to the tune of P10,000. Not a single racing day passes by without the bookies placing their fingers on the "pie", this writer was told.

This is one of the reasons why some anti-vice squads of the police and military have bulging pockets after every race day. And why not, my informant tells me, with the likes of "Delfin", "Bomber", "Berting Laspag" and "Pons and Boning", among others, getting immunity from arrest in exchange for a portion of their earnings, one surely would walk out of the hippodrome with a "helluva lot of dough," tax free.

Speaking of taxes, Vic Endriga of the Manila city hall license division, says that effective last week all producers of stage shows will be taxed 30 per cent of their earnings after deducting the cost of food.

The producers are also required to get a mayor's permit before they can stage the show or else city hall won't allow it. The target of the amusement tax drive are big hotels and restaurants which have been featuring live shows without paying a single centavo to the city government as required by the finance ministry.

Endriga said Mayor Bagatsing has already informed hotel and restaurant owners on this tax drive in a conference at city hall last week

Last Feb. 14, the city government was unable to collect some P200,000 representing its share from the entertainment shows staged in Manila's five-star hotels due to lack of coordination with hotel management. But next time around, Endriga said the city would strictly impose the 30 per cent amusement tax collection.

Garcia's body was brought to the picketline last night where his fellow workers will hold vigil until his burial Sunday. He has no relatives in Metro Manila, being a native of Lapu-Lapu City.

Dy's body, on the other hand, was taken to his home in Tala Estate. But his brain and an eye which popped out when the truck's tires crushed his head were placed in a bottle and left at the picketline in front of the

At least 20 security guards hired by the firm attacked the workers with truncheons and tear gas before the gasoline tanker, not cargo hauler as earlier reported, roared out of the company gate.

A platoon of policemen stationed several meters away was not able to prevent the outbreak of violence.

Workers retaliated by stoning the vehicle, which they identified as a Petro oil tanker,

FM's human rights record assailed at UN

GENEVA (AFP) — The human rights record of the regime of President Marcos in the Philippines has come under violent attack here during the 41st session of the United Nations Commission on Human Rights.

Sister Marianni Dimaranan, who is a co-founder and president of the Task Force on Detainees gave evidence at length yesterday and today on human rights violations in her country in the past 11 years.

Sister Dimaranan, who was herself imprisoned in 1973 on charges which were subsequently dropped, said her organization had proof of 471 cases of people who had disappeared between 1977 and 1984. It had also documented 1,895 summary executions during the same period.

The majority of cases of disappearances and executions had been recorded in Mindanao, where the government is fighting a rebellion by Moslem guerrillas, she said.

Despite the lifting of martial law, Sister Dimaranan said the number of disappearances had gone up from 42 in 1982 to 145 in 1983, and the number of summary executions had jumped from 210 to 368, reaching 445 last year.

She told the commission that she had seen with her own eyes the terrible conditions under which the families of political

She said the reason for the increase in the number of missing people and executions was because the army had a policy of not taking political prisoners.



Within two hours last night, a trail of violence in Malabon and Quezon City left four people dead and five others seriously injured in three separate incidents.

In Novaliches, a row over a lost Ray Ban sunglasses turned a delightful marathon drinking spree into a bloody affair that left one person dead and three others critically wounded.

Resty Mallari, 21, of Bgy. Pag-asa died, shortly after being rushed to a hospital, a butcher knife still dug into his left chest.

The violent confrontation took place around 7 p.m. at the end of the revelry which started at 8 that morning.

An irate Jeffrey Jones, 21, slapped with a slipper by a drinking companion, Romy Sombrano, 25, who was accusing the former of taking his Ray Ban, returned with over a dozen companions who went into stabbing and shooting hinge.

Three other people were seriously wounded with knives and a bullet while Sombrano, the object of the group's ire, was already home sleeping when the vengeful group returned.

Half an hour later, Romeo Dumpal, of Quezon City, who was stabbed the other night, joined his friend Benjamin Millamar in death at the Chinese General Hospital.

Millamar died an hour after the incident took place around 11 the other night. Around 9 p.m., two women

Around 9 p.m., two women were stabbed dead while another was seriously wounded when three robbers broke into the victims' bungalow in Malabon.

Police identified the fatalities as Remy Bagasa, 48, housewife and their housemaid, a certain Lily, 26. Remy's daughter, Cielo, is still fighting for her life at the Doctor Jose

Reyes Memorial Medical Center. The robbers reportedly fled with cash and valuables amount-

ing to P100,000.

Five more cases of robbery and holdups were recorded in

Quezon City and Manila from 1:30 a.m. to 6:45 p.m. The body of a man in his mid 20s believed to be a victim of gangland rubout was fished out from Tondo breakwater around 7:30 a.m. His body which bore stabwounds was

out from Tondo breakwater around 7:30 a.m. His body which bore stabwounds was covered with tattoos including "Jimmy M" and "Ruping B" inscribed his right and left breast. Medico-legal authorities

Medico-legal authorities said that the victim could have been killed somewhere and later dumped in the water within 24 hours before his body was discovered.

Early this morning, around 1:30, a former fire corporal was shot and seriously wounded when a robber panicked after the victim was jolted out of bed by the commotion.

Gregorio Dela Cruz, 60, of 520 Talipapa, Quirino Highway in Novaliches is now in a hospital with a bullet still embedded in his right shoulder.

His son, Renato, 25, also a fireman, was closing their carinderia when two men with handguns barged in and asked to hand over the whole day's earning.

Not contented with a measly P500, one of the robbers went into the house and scoured for valuables waking up the victim in the process.

The victim got shot when he tried to accost the intruder.

Cruz said that the suspects including a driver fled on board a cab whose plate number he failed to take note of.

President Marcos announced in a press conference yesterday that Gen. Ver would be allowed to return as chief of staff if he is acquitted.

"There is a formal agreement among the senior officers of the armed forces that if Gen. Ver is acquitted he will be returned to his position," Marcos said in his first meeting with press in 8 months.

Lt. Gen. Fidel V. Ramos was named acting chief of staff after Gen. Ver filed a leave of absence.

At the Sandiganbayan yesterday, Galmans' lawyer, Lupino Lazaro, told presiding justice Manuel Pamaran the family refused to testify unless 23 of the accused military personnel who have been denied bail or have failed to post bail are locked up in a civilian jail as the court had earlier ordered.

Pamaran had yielded custody of the accused to air force chief Maj. Gen. Vicente Piccio, who claimed military law requires accused military personnel to remain under their commander's custody pending trial.

Pamaran put out new subpoenas for the Galmans, threatening to hold them in contempt if they do not appear in court on March 4 and 5.

Tuesday's hearing included testimony from 11 l'ilipino reporters and photographers at the airport the day of the killing.

One of them, Ben Malumay of the tabloid "People's Journal," said he and the others would have been able to take pictures of the actual assassination had they not been told by a colonel to stay in a place where they could not see the airport tarmac.

Malumay said Col. Vicente Tigas of Marcos' presidential security command told him and the other journalists to stay inside an airport jetway because that was where Aquino was going to pass.

Tigas is among the alleged conspirators. Larry Sipin

ME peace initiative

CAIRO, Egypt (AP) Osama El-Baz, a key adviser to President Hosni Mubarak, flew to Israel on Tuesday to meet with Prime Minister Shimon Peres, sources close to the government reported.

Mamdouh El-Beltagi, head of the government information service, confirmed that an Egyptian envoy had been dispatched to Tel Aviv but refused to name him.

El-Beltagi said he could not say when the emissary would meet with Peres but said: "He's going there to meet the Prime Minister,"

Peres' office told the Associated Press in Tel Aviv it has "no information about the arrival of any Egyptian imis-sary." A staff member who answered the telephone in Egypt's Tel Aviv Embassy denied that El-Baz was there.

Mubarak announced on Monday he was sending El-Baz, head of his political affairs office, to Israel to seek ways with Perez to promote Middle East peace

efforts and improve bilateral ties. Later Monday, Israeli Energy Minister Moshe Shahal arrived in Cairo for what Peres characterized as exploratory talks with the Egyptians.

The Israeli leader said in an interview with the Associated Press that Mubarak's offer to play host to talks between Israel a Palestinian-Jordanian delegation "deserves a careful and positive study."

The President made the offer in an interview published Monday in the New York Times in which he also suggested that the administration of US President Ronald Reagan consider playing host to such talks.

El-Baz would be the second Egyptian official to meet with Peres in less than a week. Mubarak sent an envoy to Bucharest late last week to meet with Peres, who was visiting the Romanian capital, Although officially unidentified, diplo-matic sources in Cairo said that emissary was Mohammed Abdelforeign relations committee.

The exchange of envoys signaled a marked warming of the chill that has pervaded Israel's relations with Egypt since Israel's June 1982 invasion of Lebanon. Egypt, which signed a peace treaty with Israel in 1979, is the only Arab country maintaining relations with the Jewish state.

On Monday, Mubarak said he was sending El-Baz to Israel to discuss "the recent events in the Middle East, the future of relations and what we should do to push the peace process.'

The "recent events" evidentinclude the signing on Feb. 11 of an agreement between King Hussein of Jordan and Palestine Liberation Organization leader Yasser Arafat on a "framework for common action" on the Middle East situation.

Among its provisions was one for negotiations involving a joint PLO-Jordanian delegation, Israel has refused to talk with the PLO, which it considers a terrorist organization, but Peres did not rule out on Monday negotiations with non-PLO


Striking miners divided

LONDON (AFP) - More than 1,300 miners Tuesday returned to work, National Coal Board (NCB) figures showed, as talks continued between the National Union of Mineworkers (NUM) and Trades Union Congress (TUC). The number quitting the

50-week strike over pit closures was 1,330, the NCB said, including 600 in the militant Yorkshire region. Yesterday 3,807 went back, the highest total for any day yet.

The NCB said more than 92,000 of the 186,064 NUM members were on the job today. When working miners reach 93,033 the strikers will be outnumbered. The flow back so far this week is universally attributed to the lack of peace hopes, following the NUM leadership's rejection of the latest NCB proposals.

NUM officials led by union president Arthur Scargill had 7 hours of talks yesterday, and discussions resumed yesterday. The pit supervisors' union NACODS was also involved in





OSLO (AFP) - Former Norwegian diplomat Arne Treholt, accused of spying for the Soviet Union and Iraq, argued in court yesterday that allegedly classified documents seized at his apartment were for the most part nothing more than press publications and declassified files.

Treholt, answering the charges on the second day of his treason trial at the high court of appeals in Oslo, also contested statements he made right after his arrest on January 20, 1984. He said he had

been in a "state of shock" at the time.

The 42-year-old former UN diplomat and director of the Foreign Ministry press service said that court experts on foreign affairs had failed to understand the documents in his Oslo flat.

Referring in detail to the 832 documents confiscated in his apartment, Treholt said that some were reports available from the Economist magazine in London. Others, he said, were documents downgraded by himself as state secretary for the law of the sea - a post he held from 1976 to 1979 - after their contents were no longer needed to be kept secret.

Only 14 of the documents contained classified information, he

Treholt said the archives had been sent from his office at the Foreign Ministry to his flat in New York after he was transferred to the Norwegian UN delegation in 1979 and had been put in his

Strike called off

WARSAW, Poland (AP) -Solidarity chief Lech Walesa, claiming his outlawed trade union had forced the government to back down on its plans for sweeping food price hikes, on Tuesday called off a nationwide protest strike.

Walesa and underground Soli-darity leader Zbigniew Bujak said their call for a 15-minute general strike on Thursday had "forced the government to make a tactical concession."

In a joint statement, the two Solidarity leaders urged Poles to stage other forms of protest against government economic policies, but did not elaborate.

UL-HAQ DISSOLVES CABINET

ISLAMABAD, Pakistan (AP) — Military ruler Gen. Mohammed Zia Ul-Haq dissolved the Cabinet Tuesday after four of his ministers were defeated in national assembly elections, Pakistan's first in 8 years, Although tallies were incomplete, some of the results were seen as setbacks for Zia's military regime. The general, who had hundreds of opposition leaders arrested before Monday's vote, had said the election for the 217-seat assembly would be the first step toward an end to martial law and return to democratic government.

5 KILLED IN COLD BLOOD

HARARE (AFP) - Five officials of Zimbabwe's small opposition United African National Council (UANC) party were dragged from a train in the southwestern town of Hwange and shot dead late Sunday by supporters of the ruling Zanu Party, an eyewitness told reporters.

Speaking at a press conference marked by a highly unusual joint appearance by UANC leader Bishop Abel Muzorewa and main opposition figure Joshua Nkomo, the eyewitness said the two men and three women were slaughtered in cold blood on the platform of Hwange station.

Bishop Muzorewa charged that the ruling Zimbabwe African National Union (ZANU) of Prime Minister Robert Mugabe had paid the killers \$400 to assassinate the UANC officials as part of a terror campaign against the country's minority parties.

EX-HK BANKER ARRESTED

TAIPEI (AFP) — A former Hong Kong banker was arrested Sunday for allegedly defrauding a Hong Kong bank of six million US dollars in 1982 and will be tried in Taiwan, police

The man, identified by his Taiwan identity card as Feng Wei-Ming, 34, was an official of the Hang Seng Bank Waterloo Branch in Hong Kong in 1982 when he forged two money orders worth five million and one million US dollars respectively with a colleague's signature, police said.

An accomplice identified as Huang Chun-Hui deposited the money orders in another bank in Hong Kong, the Standard Chartered Bank, which received an approval from Feng on the money orders.

DHAKA (AFP) - Five members of a family have died in a head-on collision between their car and a passenger bus near the

southeastern port city of Chittagong, police said Tuesday.

Eyewitnesses said the impact of the collision yesterday on the
Dhaka-Chittagong highway threw the car into a roadside ditch
and killed the man, his three daughters and their grandmother

No further information was immediately available.

M.E. PEACE TALKS HOPES HIGH

WASHINGTON (AP) - US officials said Monday prospects for Middle East peace talks appear a little brighter, but expressed doubt the Arabs had offered enough to bring Israel to the bargaining table. "They are only 10 per cent there," said a senior State Department official of the agreement reached by King Hussein of Jordan and Yasser Arafat of the Palestine Liberation Organization on how to negotiate with Israel.

Mengele in drug traffic

WASHINGTON (AP) - The CIA had reports as far back as 1971 that Dr. Joseph Mengele, one of NAZI Germany's most notorious war criminals, was "heavily involved" in drug trafficking from his residence in Paraguay, according to documents released Tuesday.

The declassified government documents also include an unverified report that Mengele's roomate in 1968 in Paraguay was Martin Bormann, Hitler's designated successor.

Bormann is thought to have died in 1945 in Berlin, but there have been recurring reports over the last four decades that he may have escaped to South America.

During World War II, Mengele was chief doctor at the Auschwitz death factory where more than 1 million Jews were killed as part of Adolf Hitler's "final solution."

Mengele, who would be 73 if still alive, is

the most wanted NAZI still at large.

The declassified documents were obtained Senators Alfonse D'Amato and Arlen Specter who are involved in the recently intensified hunt to find Mengele.

The Justice Department last month announced it was conducting an intensive search to find Mengele and the US Army is investigating reports that it may have had Mengele in custody shortly after the war.

Kathy Pherson, a CIA spokeswoman, said her group had turned the information over to different government agencies, including the State and Defense Departments, when it was

The heavily censored documents also include a report the Mengele had undergone plastic surgery to make himself appear much younger.

'As you where!"

In his first press conference this year held in Malacanang yesterday the President made everybody know that he will reinstate Gen. Fabian C. Ver as chief of staff of the AFP, the same job he was holding when the majority members of the Agrava Board linked him to the Aquino-Galman assassinations.

From the very beginning, the return of the general to the top military post has been anticipated, Mr. Marcos made this evident when he expressed full trust and confidence in the innocence of the AFP chief and took a side swipe at the majority report by saying it was full of doubts and inconsistencies.

The U.S. government has made known its negative thinking over the Ver return when a visiting State Department official said so in so many words. This interventionist sentiment naturally strengthened the resolve of Mr. Marcos to stick to his original plan, if only to show to the Americans that they cannot dictate on purely Philippine affairs.

With the Ver return, Lt. Gen. Fidel V. Ramos, acting chief of staff, will revert to his old post of deputy chief and head of the PC and the INP. From the very onset, Gen. Ramos knew he was only a space filler, so to say -

a pantakip-butas in the dialect.

When General Ver finally comes back, the status quo ante will return with him to the entire military establishment. Everybody will fall back to the command of "As you were." The same policies will govern, the same cliques will rule, the same favorites will sing "Happy days are here again,"

The AFP will revert to its old, creaking, weary, unimaginative state, run by old generals who not only do not die but cannot also fade away.

The Southern Command of the Armed Forces did a good job in the operations that culminated happily in the release of Bishop Escaler and his eight companions from their MNLF abductors.



Friends of Adora Faye

I have never met Adora Faye de Vera, Nor have I met the soldiers she claims made her suffer, back in 1977, and, today, 16 months going. But I have put toge-ther here pieces of a letter she wrote - maybe alone, maybe with some help -toward Christmas last year, so that her friends may know she is confined at the V. Luna Hospital - and pay her a visit from the world of the living.

I am writing this letter, not even knowing whom to address yet hoping it will be forwarded to those who can

Back in 1977, my phy-

sical and mental torture was so total and systematic that years after I was released, the mere sound of an iron door clanging shut, tapping of boots, and the tweeting of a horn similar to the one in Col. (Alejandro) Galido's car, were enough to make me sleepless for nights.

The feel of my husband's arms around me would send me screaming in the night. It took five years before I could finally go through the details of my safehouse [Houses believed by government critics kept by military intelligence to extract information from political prisoners without offi-cial liability. The defense establishment has categorically denied keeping safe-houses.] experience without breaking down, and 7 years before I could write about it with understanding.

Until now, I can remember with clarity all the exact words used in the grilling, the abuses, lewd remarks, insults, screams, and accusations; the whole process of interrogation. Recollections still bring tears but the tremors and cold sweat are, thankfully, gone.

Imprisonment in a safehouse is given beautiful names by the military — neutralization, sanitation, rehabilitation — call it simple brainwashing. In such a short span as 9 months, everything I had learned and valued so

far in our religious and con-servative family was systematically unravelled and replaced with the most odious

By persuasion and intimidation, I was taught to drink and smoke. I was continuously regaled with stories of torture and how successful these were in eliciting information from detainees. while my oftentimes innocent remarks about human rights, concern for the poor, and gentlemanly behavior of officers were derided or

labelled subversive.

No wonder, I was confused and disoriented after I was returned to my family. I didn't realize that it was result of successful "rehabi-litation." Because we have institutions to offer therapy for torture victims, I had to rely on the patient support and sympathy of newfound friends in the rural areas to recover my peace of mind.

Respite from harassment,plus the pastoral surroundings, encouraged me to put experiences in writing. Military response to the exposure of torture had been quick and typical - I was tagged a rebel commander and a price was issued for my capture, dead or alive. By Dec. 1977, I took to the hills, a near-wreck.

On Oct. 1983, I was shot at by military troopers while preparing breakfast in a cottage at the Bicol mountains. My leg bones were shattered by gunshot.

I am confined, not in a hospital ward where nurses can attend to me, but in the Security Division Office of a military hospital, under guard by security personnel. Only members of my immediate family are allowed to visit me, and even then, they are not permitted to stay long.

I have to perform my daily activities by myself -

washing dishes, changing beddings, hanging out clothes to dry. This involves almost comic body contortions and positions, because I have to balance the weight of my body, take care that my injured leg is not bumped, while maneuvering a pair of crutches.

The positions are comic, but the results are not. I have suffered numerous bruises, abrasions, strained muscles, and falls. Last March 1983, I slipped on my way from the bathroom and suffered a refracture which

further retarded recovery.

Until now, not one of the officers or men whose torture I exposed years ago (has) ever been investigated, and some have even been promoted.

Today, I am physically disabled but still not allowed to go home where my family can take care of me.

Joker Arroyo says that the prosecution should have a new rules, promulgated by the Supreme Court in Jan. 1, 1985, tend to favor the accused now "for some inexplicable reason."

Arroyo also cited the case of Elvin Laurel and Santos Abellanosa, charged with illegal possession of explosives before the Manila RTC in connection with the alleged explosion in the premises of Manila Hilton Hotel in Sept. 1982. Both were ordered released on a bail bond of P10,000 each by Manila RTC Judge Jorge S. Imperial.

Censors chief Maria Kalaw Katigbak said that portions of the film previously deleted (i.e., rally menes and singing of the workers version of the song Bayan Ko) may stay but ordered the film to be classified for adults only as it "contained lascivious scenes and excessive violence." Katigbak was referring to the sexy scenes of Carmi Martin and the late sex siren Claudia Zobel and the killings in the end of the film.

The censors chief qualified that the film may be reclassified for general patronage if they agree in writing to have the alleged obscene portions deleted.

Rejecting the Anti-Women in Art and Media

A passing survey of the images of women in the arts and media shows the changing attitudes and values with respect to women's role in society. These values and attitudes have — more often than not - been obstacles in the way of woman's fulfillment and liberation. Often prejudicial to her interests, they have reflected the biases and injustices imposed and perpetrated by

traditional male-dominated society.

To take a specific problem, the nude in art raises issues vis-avis the feminist viewpoint because of the subject's erotic potential. One may ask how the feminist is to regard the female nude in painting, sculpture, photography, and the cinema.

In Western art history, the original motivation of the nude among the classical Greeks was to create the image of ideal form. The classical artists observed in their art what they believed were the ideal proportions of the human figure as laid down in their canons. These nudes elevated on pedestals were to have the qualities of aloofness and restraint, of being above common humanity with its struggles, griefs and fleeting emotions. These images, however, belong to the Platonic idealist world view in their quest for the absolute, unchanging, and universal, beyond "the shadowy and imperfect reality" in which we humans exist and function. Such a concept can no longer hold in our contempoworld of change and struggle. But the nude in art has sur-

vived under new motivations.

First, the nude may reflect a strong scientific concern on the part of the artist, a basic interest in comprehending the body as organic structure, in developing a sensitivity to the balancing and continually adjusting forces in the dynamic human figure. This is, I think, an essential training in figurative art, especially in the realist style which is based on keen observation and which re-quires a solid anatomical basis in order to be credible and convincing. Along with this scientific attitude, the artist may also be interested in capturing individualizing features of the human body in a vast range of physical characteristics and types, as well as in developing a keen eye for gestures, stances, poses, movements, and it is the nude unencumbered by drapery and clothing which lends itself best to this interest.

Secondly, in what we may call the humanist motivation, the nude female form, as in the case of Rembrandt and the masters, may be used as a sensitive vehicle for the expression of inner feelings and states, and in so doing, the artist may show the intimate link between the physical and the spiritual, the body and the mind. In this approach, the artist explores the full expressive potential of the human figure in order to convey ideas, values, and attitudes in realist or symbolic works, thus contextualizing the nude in an ideational framework.

On the other hand, the representations of the female nude in art can very easily, and so often, become prejudicial to women.

This is when they effect the reification of woman - in which case woman is reduced to a mere object devoid of consciousness no better than a table or chair. The nude is likewise prejudicial and anti-women when woman is represented as a mere object of man's desire, a passive body displayed to the male gaze to which it proffers or intimates pleasure in the implication that it is the man who looks in an active role and the female looked at in a passive and submissive role.

Sometimes, third-rate artists use the exalted phrase "celebration of the female form" as" an excuse for inflicting their cheap commercial nudes on the public. Of course, the most blatantly sexist, as well as tasteless, are the nudes, whether in painting or slick photography, in seductive, sultry, and soliciting poses, or those clothed skimpily in a suggestive manner such as proliferate in girlie magazines and posters. It is especially in these cases that women as models lend themselves to sexual exploitation, so

rampant in this time of economic crisis.

It is particularly in this regime that we have witnessed the massive exploitation of the Filipino woman. Factors which have contributed to this deplorable state are the tourist industry which has made our women its major attraction to foreigners (as in the come-on poster "There's More Where She Comes From), the corrupting influence of the American bases, the general poverty and with it the lack of educational and employment opportunities, the imperialist grip on our culture which, for instance, has produced local bunnies for the Playboy Club from our young and susceptible Filipinas.

There are many venues of woman exploitation in the media:

1) the commercial bomba films, local or foreign, sometimes organized by the State into festivals of smut; 2) ECP bomba films which are privileged productions that swell the coffers of the State; 3) pornographic magazines such as Tiktik, Sakdal, Tikatik, etc., pornography of the cheapest kind, an insult to the intelligence of the Filipino masses who have little access to good reading fare because of poverty, a shameless violation of human dignity and of women in particular, like offering kanin-baboy to humans. It is significant to note that a number of these magazines which persist in surviving contain crude government propaganda in between the lurid comics; 4) sexist ads in print and TV, such as young skimpily-dressed women in liquor ads implying that woman too is just another commodity for male

Bomba films made from the male chauvinist point of view debase woman and portray her as sexual object, mindless animal or helpless victim. Does this mean then that films should not portray sex altogether - sex, after all, is still a part of life? The old criterion of the scene being called for by the story is not

The 13-team international fact-finding mission went to various regions of the country last Sept. 11-17 to verify and document alleged human rights violations, as well as trends involving alleged militarization and military abuses from 1977 to 1983. At least 45 human rights advocates from different countries took part in the investigations.

On February 27, 1945, when the Commonwealth government was restored, Roxas was already being boosted for the presidency of the republic to be established on July 4, 1946, while the pro-Osmena Sr. camp were lumping him (Roxas) with Jose P. Laurel, Jorge B. Vargas, Benigno Aquino Sr., Quintin Paredes, and others who accepted positions in the Japanese-sponsored republic.

And in the wings, if not right in the middle of the circus ring, were the likes of U.S. Secretary of State Ickes threatening to cut off American aid if "collaborators" were to dominate the political scene once more.

Following Osmena's address, MacArthur strode to Mrs. Osmena, kissed her on the right cheek, and said, "I am so glad you are home." Immediately afterward, Osmena kissed the other cheek of his wife. MacArthur then shook hands with Osmena and stepped quietly out of the hall. The ceremony was over. The Commonwealth government was formally home.

Opinions of nationalist historians notwithstanding, I wish to record here that Pedro A. Perno was born on Feb. 27, 1857. He was a candidate for the speakership of the Philippine Assembly in 1907, but was defeated by — guess who? — Sergio Osmena Sr.

As cited in the report, there were, from 1977 to 1983, 334 missing persons, 1,450 victims of "salvaging," 11,270 persons arrested and detained. In 1984, the report said, there were 137 cases of disappearances and 445 victims of extra-judicial killings.

solid enough because the story line itself may be tailored to focus on a series scenes, like a picaresque adventure story. It seems, however, that sex scenes may not be necessarily objectionable in certain cases. One is when the viewpoint in the total human situation in which they occur is not prejudicial to women, that is, they are not mere sex objects but total human beings who express their human personality in a situation which is contextualized in a larger whole. Another is when the scenes are integral to, or perhaps comment on, the socio-cultural and historical milieu, with its mores, values, and attitudes, and that it is not a scene abstracted and existing for itself as a gratuitous insert, blown out of proportion, but an insightful comment on the human person as a social and historical being.

The exploitation of women in the media and the arts has both social and political implications. Basically, it reflects the bourgeois capitalist drive to exploit human needs, instincts, and weaknesses for financial gain, and to convert all things, including human relationships, into commodities. Likewise, it is an escapist strategy to divert attention from the current crisis and from vital issues to focus on an isolated function which is per se instinctual, non-rational, and historical. It hinders women from gaining self-respect and achieving liberation because of its continual attack on her humanity.

It is then imperative for feminist groups to expose and fight the various ways by which the Filipina woman is exploited today. In the field of the arts and media, including film the answer, however, lies not in censorship which can be quite arbitrary, sweeping away the good with the bad and further limiting our already much-reduced freedom, but in a large campaign to raise the consciousness of women and thus awaken all to the necessity of breaking down the enclaves of traditional male and class privilege. By doing so, the way will be prepared not only for the emancipation of the female sex but of woman as worker and creative being, a requisite for the attainment of a truly human order.

moment was during the incumbency of Defense Secretary Ramon Magsaysay. They were under civilian authority then.

Someone once said that war is too serious a matter to be left entirely in the hands of the military. How much more the entire government? The military can survive only if it cleanses itself and only if they become the military arm of a civilian government.

All governments need a good military arm. And that is what we hope to see. We sincerely believe that despite the bad image of the military at present, 70 per cent of the military are decent patriots. They cannot discipline the soldiers if the soldiers are not politicized.

"Unless they become instruments for the restoration and preservation of our democratic traditions, their operations against the so-called subversives will be counter-productive.

The soldier who fights or dies for a dictatorial rule is sacrificing his life against his own interest. He would be serving his interest, not to mention the interest of his family more, by joining the rebel forces.

The Army must recover its lost prestige. We would welcome the day that they regain the prestige they had during the Magsaysay era. Only they can do this.

At the moment, the Army is its own greatest enemy. The harm that it has inflicted on itself is much greater than the harm that the MNLF and the NPAs have done to them.

He perhaps was thinking of the government of Mr. Marcos which has lost its credibility because it is not really democratic and may lose to the Com-

munists in the battle of ideas. In fact it is losing to the moderate Oppositionists.

Q. But wasn't the Conference at the Kapihan democratic, both Doy and Ople being given equal exposure and opportunity to answer the public?

Yes, but in the TV showing of Channel 13, the camera seemed to have scanned the place, Doy and even I appeared for a second, and focused itself on the face of Ople for a long time. CALGARY, Canada (AP) The International Olympic Committee will choose the host cities for the 1992 Summer and Winter Olympics in Lausanne, Switzerland, during the committee's 1986 annual meeting, director Monique Berlioux said

The committee's executive board is meeting this week in Calgary, site of the 1988 Winter Games. Calgary beat out competing bids from Falun, Sweden, and Cortina D'Azampezzo, Italy, during a similar meeting in 1981. At that session, Seoul, South Korea, was chosen to play host to the 1988 Summer

The current meeting in Calgary is one of several gatherings the IOC holds each

The decision on who will play host to the 1992 Winter Games will not be made until Oct. 17, 1986.But already, cities interested in being picked are spending thousands of dollars to be in Calgary to make their intentions known.

There is a delegation from Falun, plus others from Lillehammer, Norway, Albert-ville, France, Berchtesgaden, West Germany, Sofia, Bulgaria, and Salt Lake City, Utah in the United States,

The city delegations make their appearance at such meetings to express their committhe games. Calgary to officials followed the same principle in 1964, 1968, 1972 1978 before that city was picked for 1988.

England out of running in cricket

SYDNEY, Australia (AP) India's spin bowlers virtually knocked England out of the World Championship of Cricket series at the Sydney Cricket Ground Tuesday.

Left-arm spinner Ravi Shastri and 19-year-old student Laxman Sivaramakrishnan took three wickets each as England plunged to an 86-run defeat.

England also lost to Australia

on the opening day of the series in Melbourne 9 days ago. Indian opening batsman Krishna Srikkanth who slammed 57 runs off only 53 balls, was named man of the match.

MACAU, Feb. 26 (AFP) - China swept to the top of World Cup Asian Preliminary Group 4A with a runaway 8-0 win over Brunei here today.

Brunei has become the whipping boys of this

group, having conceded 8 goals to Hong Kong

just four days previously.

China, held to a scoreless draw by Hong Kong in the group opener, then beat Macau 4-0 and today's decisive win puts them two points clear of Hong Kong.

China will now face Brunei in Hong Kong on Friday and, on the evidence of today's display, another rout looks certain.

Despite the final impressive goals tally, it took China 26 minutes to score against Brunei which played with 10 men back in defense on the narrow Macau ground.

The Chinese, seeking to at least equal the 8 goals rivals Hong Kong had scored, were beginning to look anxious until the 26th minute breakthrough which came via the penalty spot.

Brunei defender Yakub Bakar brought down Liu Haiguang and striker Zhao Dayu, back in the side after missing the Macau game through injury, made no mistake.

Three goals in a series of lightning strikes in the final 7 minutes of the first half had Brunei on the ropes.

Jia Xiuquan was on target from close range in the 37th minute and then Li Hui completed a solo run with a cracking shot in the 40th minute which gave Brunei goalkeeper Amat

In the last 30 seconds of the first half, Liu Haiguang followed up on a Zuo Shusheng shot which Amat failed to hold and drove the rebound home from close range.

A double figure scoreline looked possible when Zuo Shusheng and Jia Xiuguan ripped through the Brunei defense a minute after the restart and set dangerous Gu Guanming up for the fifth goal.

Poor finishing and the crossbar prevented China from increasing its lead until the 66th minute when Zuo Shusheng, one of the best players on view, cracked in China's sixth goal,

A controversial penalty decision gave Zhao Dayu his second chance to score from the spot and he made no mistake

The impressive Chinese striker then followed that up with the best goal of the game which came in the final minute, scoring with a tremendous volley from 25 meters.

Jun Castro's target

18 elite runners for 1986 PTWM

Firmed up by the success of his 3rd Pilipinas-Third World Marathon, last Feb. 17, race organizer Jose V. Castro Jr. bared bold plans (e bring in no less than 18 elite runners in the 2-hour-10-minute to 2-hour-14-minute category next year.

Castro, who saw Belgium's Jose Revijn set a new PTWM record of 2:21:11 in his very first marathon triumph after 21 tries, said the Belgian would be back to defend his title.

Runners from France, England, West Germany, Switzerland, Holland, the United States, Australia, Japan and seven other Asian Third World countries will form the foreign field in the 1986 version, Castro said.

The man recognized as the dean of Philippine marathon organizers said 8 world-class women runners headed by Belgian Denise Verhaert, winner of the 3rd PAL-Manila International Marathon last year and of the PTWM this year as well as the all-comers record holder at 2:45.27, will complete the overseas field in next year's edition.

Miss Verhaert, will be back with tougher competition from compatriot Marie Duerbroeck, a 2:32:32 marathoner who represented Belgium in the Los Angeles Olympic Games.

Among the tourist runners who competed in the Feb. 17 race and promised to return were Keizo Yamada, the Japanese winner of the 1953 Boston Marathon, and Francis Kavanaugh of the Royal Hong Kong Police Force.

Yamada said he will be back with some 30 to 50 tourist runners from Japan while Kavanaugh wrote from Hong Kong that more runners from the British Colony have expressed interest in running in next year's race.

In a letter to Castro, Kavanaugh said "my stay in your country was a real pleasure... Efficient organization and control of the race was of a high order indeed."

Castro said the Third World Marathon is bidding to host the 1986 congress of the prestigious Association of International Marathons (AIMS) to showcase the big strides that long-distance running has made in the Philippines.

The AIMS is an association of the world's biggest marathons,

Twelve foreign countries, led by the United States and China, have been invited to compete in the multi-nation meet.

Vice-Gov. Rodriguez said prominent sports leaders in the South have pledged their support to insure the success of the tournament. Among those who have already expressed financial aid are Minister Concordio Diel, Misamis Oriental Gov. Fernando Pacana, Mayor Pablo Magtajas and Mayor Miguel Paderanga.

Pedroza defense

LONDON, Feb. 26 (AFP) — Panama's Eusebio Pedroza has signed to defend his World Boxing Association featherweight title against British and European champion Barry McGuigan, London promoter Frank Warren said today.

This much was gathered from FIDE president Florencio Campomanes yesterday at the press conference he called to announce his affirmation of that Feb. 15 decision to terminate the Karpov-Garri Kasparov championship encounter after

A 12-point score could be achieved by drawing all 24 games, and it was precisely the great number of draws obtained in the protracted series - 40 in all - which led to Campomanes' decision to end it all, "in the best interests of the game," the PIDE president iterated.

Campomanes said there is now a clamor for reversion to the traditional 24-game series after the only-wins-to-count format first introduced in 1978 was exposed as faulty because both Karpov and Kasparov have achieved such excellence in the game either could, by simply abandoning attacking play, always play to a draw.

Under the old format of a

Under the old format of a 24-game series, a champion retains the championship by equalling the total points of his challenger.

All that's definite now about the upcoming rematch between Karpov and Kasparov is the date - Sept. 2, which will be the day after the FIDE congress ends.

Philippine Chess Federation president, Justice Federico Moreno, told WE Forum he had recommended to Campomanes that the coming 24-game championship call for at least three victories by any one side out of the 24 games before that side can claim the crown.

This, Moreno said, would preclude the rash of grandmaster draws that marred the aborted championship match.

The setup

With his usual flair for the dramatic, Florencio Campomanes, president of the Federation Internationale des Echecs (FIDE), kept the gathering of local and foreign media with bated breath at his press conference yesterday.

Conducting the confab in a runabout way, Campo first held a question-and-answer session before he made his statement. It almost always is the other way around, but Campo is never predictable.

After having run every question to the ground in his usual suave, sometimes cynical, sometimes condescending, but almost always charming, style, Campomanes read his statement, with appropriate pauses that swelled pregnant at the most crucial points.

"I have," Campomanes began, "within the last 9 days. . . been receiving requests to alter the February 15th decision (to end the match without decision). . ."

without decision)..."

Here we go, I said to self, Campo's stupendous chess swindle about to be sprung.

"Foremost, and most direct and most persistent has been from Mr. Anatoly Karpov . .

"You are familiar with the reasons for that decision? Let us review them . . ."

These interspersed with quick, cool glances

at his audience, which hung on his every word.
What reasons could there be for a change of that decision? Campo asked. Why should we resume the match from where we left off? Then he spoke of Karpov's open letter "which he had

distributed to media in Moscow" and which he said he had read in full when still in Athens en route to Manila.

"This circumstance alone is unprecedented, and deserved total attention. Note the emotional tone. He wishes to redeem his 'blasted sports and public reputation.'

"Have the conditions changed today to warrant a reversal?

"Assuming it is resumed, they'll play, say, by March first. Two weeks interval. Mr. Karpov shall have rested, it can be alleged.

shall have rested, it can be alleged...
"Will the former excellence of play be

"If I become convinced of the wisdom of the proponents of resumption, or succumb to the fleeting but fierce pressures of "the show must go on" groups...

"The organizing committee will dutifully renew preparations and in quick time place Sports Hotel or Trade Union hall in full match gear . . . bring (the other principals of the match) back to Moscow . . .

"Mr. Karpov will have a chance to redeem, to paraphrase him, his blasted sports and public reputation.

"Mr. Kasparov will have his opportunity to gamble with his 25 or 30 per cent chance to win the match

Here it comes, I whispered to Jun Engracia, editor-in-chief of PM, he's going to bow to the clamor, he'd say, and order play resumed. I was all ready to grab the microphone again and ask, trying hardest to keep sarcasm out of my voice, if meanwhile, Mr. Karpov has already thanked him for the respite.

I never got to the mike. In fact, I almost clapped when Campo announced that he was sticking to his Feb. 15 decision to end the match without decision and start a new match from correct in Sentember.
