Ople says government cleared of labor repression charges

been stricken off the list of countries being investigated by the International Labor Or-ganization (ILO) for alleged vio-lations of its conventions on freedom of association.

In a press statement, Labor Minister Blas F. Ople said the Philippine delegation to the 71st ILO Congress in Geneva last June persuaded the organization to clear the country despite efforts of two representatives from radical Filipino labor

Ople, who revealed the ILO move to some newsmen, said he reported the matter to President Marcos as soon as he arrived from Geneva last week, He headed that delegation. He said the Philippines was

excluded from the list of 65 countries, mostly from the third world, summoned by the ILO Committee on the Application of Standards, to give additional information on the compliance of these countries with various ILO Conventions.

The countries reportedly included Malaysia and Thailand as well as 10 developed nations such as England and Japan.

However, it maintains that the situation is well within manageable levels and thus, no cause for alarm.


This view was articulated by Stephen W. Bosworth, US Ambassador to the Philippines, in his address to the Philippine Columbian Association forum yesterday, during which he traced the roots and explored the prospects of Fil-American relations.

"I think the insurgency problem has seriously increased in the last two years but this rise is no cause for concern," Bosworth said.

He said the insurgency situation in the country is "by all means imminently manageable" as the rebel forces are still behind in terms of political organization and could only mount limited military operations.

Bosworth said insurgency tivities of both the communist New People's Army and the secessionist Moro National Front have not

He said that all is required is a concerted national effort to deal with or face up to the challenge posed by the rebels.

He said current anti-insurgency drives coupled with government livelihood programs in the countryside if sustained, could control and thereafter reverse the trend.

At the same time, the US Ambassador reiterated that his government would continue to support government's initiative at revitalizing democratic institutions, saying that this had in fact been "a permanent feature of US foreign policy" on the Philippines.

Birthday gift for Ma'am

It was a morbid gift that a group of Catholic priests and Protestant ministers had planned to give to the First Lady, Mrs. Imelda R. Marcos, on her 55th birthday last Tuesday, July 2, according to the Associated Press dispatch in yesterday's WE Forum.

The gift was a black coffin symbolizing the death of

democracy in our country. Said the Rev. Ben Moraleda before the crowd of demonstrators which had intended to march to Malacanang but which was stopped short by the usual anti-riot policemen:

'It is her, together with Marcos, who had caused the death of democracy and put Filipinos in the coffin."

While many may not agree with the gruesome use of the black coffin, most Filipinos, we are sure, suffering from the worst economic difficulties in their lives, will say that the message intended for the First Lady was apt and well-deserved.

If democracy has died in our country and the people are suffering not only hunger but also restrictions on their liberties, it is not alone Mr. Marcos who is to blame but also his wife and helpmate who has served as his right hand all these years.

Had she used her woman's influence and her wifely charms in guiding her husband along the pathways of righteousness, justice, freedom and democracy in the last 19 years, how pogressive and happy the country and its people would be today!

But the wife not only went along with her husband in all his devious plans. She also helped him actively in implementing the dark and evil scheme of seizing power, doing away with all the democratic institutions, snatching from the people all their human rights and now plotting to remain in power indefinitely.

Most serious indictment yet

The expose, starting in yesterday's Malaya, our sister publication, about the top government leaders and businessmen cronies, starting with Mr. and Mrs. Marcos, who have invested enormous sums of money in the United States is a bombshell, the repercussions of which we cannot yet forecast.

Although a similar report, based on the same San Jose (California) Mercury News, was earlier published in Business Day, it failed to create the shock waves expected.

But Malaya's three-part series is more inclusive and more meaty and, therefore, a much bigger bomb, with a heavier deto-

Immediately after the publication of the first part in Malaya yesterday, the first after-effect came off: the irrevocable resignation of Energy Minister Geronimo Velasco from the Marcos government. Velasco was the fourth in the list of investors among the Top Ten.

In his resignation letter to Marcos, Velasco said he cannot continue to serve in the Marcos Cabinet "without the confidence of the people."

I do not know if other top government leaders included in the list will act similarly. If their conscience is clear, they should also quit. Otherwise, the people will have reason to conclude that

they are guilty.

This Malaya expose, although based on the San Jose (California) Mercury News, is to me, as much of a bombshell as the dastardly assassination of Ninoy Aquino. It is the most serious indictment yet of the Marcos government. It translates mere rumors floating around the past many years to hard news. Facts and figures cited in the expose cannot just be shunted off by mere self-serving denials.

How will the Establishment press react to the expose? Will they ignore it, as they have always ignored any publication derogatory to the Marcos regime under the theory that any dirt swept under the rug will eventually be forgotten?

For instance, in the case of Energy Minister Velasco's letter of irrevocable resignation, will they close their eyes to the letter and pretend that the resignation is just a bad dream?

In the next few days, we will see what will happen.

the KKK came on July 5, 1896 when Lt. Manuel Sityar of the Guardia Civil, stationed in Pasig, wrote a confidential letter to the Civil Governor of Manila saying that "individuals from the capital and the neighboring towns, especially Mandaluyong and San Juan del Monte, were enlisting men for an unknown purpose, making those who joined sign with their own blood and take a pledge of secrecy under oath and warning that one who betrayed the secret would pay with his life."

Sityar even informed the governor of the initiation fee of the KKK: one peso and 2 reales (equivalent to 25 centavos) a month, for the purchase

been distributed in San Felipe Neri, San Juan, Mandaluyong, and Pasig.

Sityar said that the KKK was highly political in nature, for it aimed to warn the people that the Spanish government was increasing taxes and the number of Filipinos to be conscripted into the army. Apparently the civil governor ignored Sityar's letter.

PUSH for health and development

PUSH stands for Panay Unified Services for Health. Launched by the Regional Development Council of Region 6 (Western Visayas), the project, according to the governor of lloilo, has effected significant improvements in the health, nutrition and sanitation condithe island of Panay.

The island (made up of the provinces of Aklan, Antique, Capiz and Iloilo and the subprovince of Guimaras) has serious problems such as poor health, malnutrition and lack of sanitation facilities.

Eighty-five per cent of children below six years old are malnourished, this in an island which reportedly produces food in excess of consumption needs. Tuberculosis, pneumonia, gastroenteritis and parasitism, top causes of deaths and illnesse are common diseases. Only 45 per cent of the households have access to safe water supply,

cent satisfied minimum sanitation standards.

Most of the island's health problems could have been prevented by simple public health measures. But many of the people did not or do not even have access to these services. As of 1982, the population

of Panay was 2.6 million, or six per cent of the total population of the Philippines.

In the late 1970s, the Regional Development Council developed a project to carry out simple public health and disease-control measures at the village level. When implemented, the project - PUSH - served as the integration point of all health and related projects being implemented in the barangays.

The activities and accomplishments of PUSH were described recently by Iloilo Gov-ernor Conrado J. Norada, PUSH

and only 65 per cent have project director, in a paper pre-toilets, of which only 35 per sented to the Seventh National sented to the Seventh National Population Welfare Congress in Metro Manila.

PUSH, Governor Norada said, uses a multidisciplinary health improvement approach which mobilizes existing community resources in providing development-oriented various services.

It employs a barangay health services delivery model whose key figure is the barangay health worker (BHW). The BHW is a barangay resident who has been trained in environmental sanitation, family planning, nutrition, control of communicable diseases, cure of simple ailments, recording vital events such as births and deaths, and community organization.

The BHW's fulltime job is to provide Integrated health, family planning and related services to his barangay.

Among other tasks, he or she mobilizes the community res-

idents for the construction of sanitation facilities, motivates potential family planning acceptors and provides users with contraceptives, and promotes breastfeeding and other health practices. He administers treatment to simple allments and refers more comments and refers more

ments and refers more complicated cases to medical facilities. He also supports disease-control campaigns that may be conducted by the rural health unit in the municipality.

The barangay health delivery system is managed by the local government which, after the first three years of the project, assumed complete financial responsibility for all project responsibility for all project costs, including the salary of the

BHW.

Through 449 BHWs now being deployed throughout the island, PUSH has made available to the people of Panay a wide range of primary health, nutrition and family planning services.

It has provided immuniza-tion to a considerable number of children, and worked for the installation of sanitary tollet

Anter's son, Celestino, Jr., told WE Forum his father was shot by patrolman Ricardo Concepcion of the Caloocan City Police inside the Amez Bakery in Lagro, Novaliches. Anter, Sr. reportedly refused to be frisked by the policeman and instead grappled with the latter's armalite. The armalite went off and

Police blotters, however, showed a different version of the story. The files said Anter, Sr. was acidentally shot by his son, near a demolition site in Lagro. They said the son came to the aid of his father who was then being chased by several lawmen. The

son reportedly pulled out a gun and was set to fight it out with the lawmen when the gun went off hitting his father.

A robbery/hold-up was staged by three armed men along Bonifacio Avenue in Quezon City, at around 9:15. The driver Ramon Santiago, 25, of Baesa Quezon City, was held up along with Dominador Lopez, 45, Leticia, Cruz, 21, and a certain "Joseph."

One of the suspects, Antonio Betaller, 21, stabbed the driver. prompting other passengers to fight off the holduppers, and started to jump from the speeding vehicle. At about the same time, a patrol vehicle of the Northern Police spotted the vehicle and quickly gave chase. All of the suspects including Jose Cortez, 17, and Roberto Bartillo, 19, were apprehended by the lawmen. The jeepney driver died upon arrival at the Ouezon City General Hospital.

While today has been declared by Malacanang as a special pub-lic holiday in a show of "cor-dial relations" between the White House and Marcos' Malacanang, thousands of students, workers, nationalists and members of cause-oriented groups are expected to take to the streets to denounce what they call "blatant US intervention in the country.

The Nationalist Alliance for Justice, Freedom and Democracy-National Capital Region (NAJFD-NCR), one of the spearheads of the protest marches, declared that the US government has continued to prop up and support the Marcos regime through millions of dollars in so-called military and economic aid.

The NAJFD-NCR added "US-Marcos combine" has now openly declared war against the Filipino people through intensified political repression and heightened military terror-

Former Sen. Lorenzo Tanada, the 'Grand Old Man' of the opposition, is expected to lead this afternoon's march Plaza Miranda to the American embassy on Roxas Blvd., scene of violent clashes between police and militant protesters who have steadfastly denounced US meddling in Philippine affairs.

A staunch anti-imperialist, Tanada, 86, will join other so-called 'street parliamentarians' in reiterating the "people's demand for the imme-diate removal of US military bases in the country."

The Bagong Alyansang Ma-kabayan (BAYAN) and the NAJFD-NCR said in a statement issued for today's "undeserved celebration" of Fil-Am Friendship Day, that the "US-Marcos dictatorship's" systematic attacks against the civilian populace are clearly visible in the government's determined implementation of LOI 1458, which the opposition calls a repressive antibarangay tanods, squatter demolitions, the revocation of the Ministry of National Defense-students accord, the incluof the National Service Law in the school curriculum, and the recent food blockade several towns in strife-torn Mindanao island in Southern Philippines, among others.

The suspects were arrested by Quezon City police hours after the incident. They were identified as Antonio Bataller, 19; Jose Cortez, 17 and Rodolfo

Cruz's petition said: "The closure order/recommendation and related actuations of respondent officials were not only arbitrary, discriminatory and without valid basis but also characterized by grave abuse of discretion and violative of due process,

"Said officials were evidently yielding to the pressure from adverse publicity which appears to be directed against Grand Inihaw and artificially sensationalized by still unnamed unknown unscrupulous persons, jealous competitors and professional detractors."

Cruz asserts that the incidents (killings) which happened within the vicinity of Grand Inihaw occurred when rallies and demonstrations were regularly being held at the Welcome Rotunda and that no more untoward incidents ever happened when rallies were held in Mendiola or Luneta.

Observers, however, noted that the violent incidents happened at night while rallies were held in the daytime. The killing of a policeman by a former policeman in Grand Inihaw on May 26, which revived this almost - forgotten controversy; happened at a time when no rally was held, they added.

Cruz suggested that her business establishment has been made a "scapegoat or sacrificial by the respondent offilamb" cials who may be "yielding to lawless elements and to pressure from an irate citizenry.'

Bagatsing restrains cops on pub raids

Mayor Ramon D. Bagatsing yesterday ordered the Manila police to "stop harassing nightclub and disco pub operators' even as he banned police units, including the city hall police detachment, from inspecting business establishments.

The mayor likewise directed Manila police chief Narciso Cabrera to devise a system that would ensure maximum results in the renewed anti-vice drive without creating irritants to business operators and the police.

Bagatsing took the move after a group of Ermita businessmen charged that police made multiple raids" on their establishments.

The group told Bagatsing that the police "raids" have been driving customers away, "great blow to their alreadydepressed business."

The club operators claimed that several police teams have been conducting inspections two or three times in one night on each club to the prejudice of the business.

The group said that due to the multiple police inspections every evening one of their business colleagues had to close while several others are planning to shut down.

"While inspections should be conducted to check compliance with permit or license requirements and other regulations," Bagatsing said, "efforts should be exerted not to discourage business entrepreneurship."

In issuing his instructions to Cabrera, Bagatsing stressed the need to remove sources of irritants that tend to thwart business stability and growth. - Bobby Burgos

Father mauls baby to death

22-year-old housewife shocked Quezon City police-men at Station I last night when she carried her dead baby in and complained that her husband mauled it in a quarrel.

Legal blow to sex trade

The rise in child prostitution labor measure, the return of and other forms of sexual exsecret marshals, the arming of ploitation of minors may yet be curbed if the authorities strictly enforce a new ordinance seeking to plug loopholes in existing vs penalizing such acts. The Metro Manila Commis-

sion (MMC) recently passed an ordinance seeking to facilitate prosecution of persons who engage the services of a minor for prostitution and/or sexual exploitation, as well as those who promote or induce the

The ordinance defines "prostitution" as the act of sexual intercourse or lascivious conduct with another person of the same or opposite sex, for monetary or other valuable consideration, and sexual exploitation as

the satisfaction of lust by any act other than sexual intercourse such as manipulation of sex organs, masturbation, oral or anal sex and similar acts for monetary or other valuable consideration.

Under the MMC ordinance, any person under 18 years of age is considered a minor.

Upon conviction, violators shall be imprisoned not less than six months nor more than four years, or fined not ex-ceeding P4,000 or both, at the discretion of the court. If they are related to 1 e minor, the maximum penalty shall be imposed. A foreign r found violating the ordinance shall also be deported after service of his

Authorities believe the new ordinance will speed up the arrest and conviction of violators because it has introduced presumptions which significantly lower the burden of proof necessary for convic-

Any person who, not being a relative of the minor, is found alone with such minor in an inn, hotel, motel, pension house, apartelle or similar establishments raises sufficient presumption that such person is engaged in prostitution or sexual exploitation of minors. This is also true for any person who, in the company of a minor not related to him, is found with pornographic films, photographs and other similar materials.

upon the owner, operator, manager, administrator, caretaker or tender of such establishments the duty to refuse admission to or otherwise prevent the and stay of a minor into their places unless accompanied by a relative. Failure to do so render them liable for imprisonment and/or a fine, Those who neglect or fail to report such acts to the authorities

shall also be punished.
Unless the minor is otherwise liable under the penal laws, he shall not be criminally prosecuted but instead placed under rehabilitation and committed to the care of his family. relatives or to the Ministry of Social Services and Development.

Most serious indictment yet

The expose, starting in yesterday's Malaya, our sister publication, about the top government leaders and businessmen cronies, starting with Mr. and Mrs. Marcos, who have invested enormous sums of money in the United States is a bombshell, the repercussions of which we cannot yet forecast.

Although a similar report, based on the same San Jose (Cali-fornia) Mercury News, was earlier published in Business Day, it failed to create the shock waves expected.

But Malaya's three-part series is more inclusive and more meaty and, therefore, a much bigger bomb, with a heavier deto-

Immediately after the publication of the first part in Malaya yesterday, the first after-effect came off: the irrevocable resignation of Energy Minister Geronimo Velasco from the Marcos government. Velasco was the fourth in the list of investors among the Top Ten.

In his resignation letter to Marcos, Velasco said he cannot continue to serve in the Marcos Cabinet "without the confidence of the people."

I do not know if other top government leaders included in the list will act similarly. If their conscience is clear, they should also quit. Otherwise, the people will have reason to conclude that

they are guilty.

This Malaya expose, although based on the San Jose (California) Mercury News, is to me, as much of a bombshell as the dastardly assassination of Ninoy Aquino. It is the most serious indictment yet of the Marcos government. It translates mere rumors floating around the past many years to hard news. Facts and figures cited in the expose cannot just be shunted off by mere self-serving denials.

How will the Establishment press react to the expose? Will they ignore it, as they have always ignored any publication derogatory to the Marcos regime under the theory that any dirt swept under the rug will eventually be forgotten?

For instance, in the case of Energy Minister Velasco's letter of irrevocable resignation, will they close their eyes to the letter and pretend that the resignation is just a bad dream?

In the next few days, we will see what will happen.

PUSH for health and development

PUSH stands for Panay Unified Services for Health. Launched by the Regional Development Council of Region 6 (Western Visayas), the project, according to the governor of Iloilo, has effected significant improvements in the health, nutrition and sanitation conditions in the island of Panay.

The island (made up of the provinces of Aklan, Antique, Capiz and Iloilo and the subprovince of Guimaras) has serious problems such as poor health, malnutrition and lack of sanitation facilities.

Eighty-five per cent of children below six years old are malnourished, this in an island which reportedly produces food in excess of consumption needs. Tuberculosis, pneumonia, gastroenteritis and parasitism, top causes of deaths and illnesses, are common diseases. Only 45 per cent of the households have access to safe water supply,

and only 65 per cent have toilets, of which only 35 per cent satisfied minimum sanitation standards.

Most of the island's health problems could have been prevented by simple public health measures. But many of the people did not or do not even have access to these services.

As of 1982, the population of Panay was 2.6 million, or six per cent of the total population of the Philippines.

in the late 1970s, the Regional Development developed a project to carry out simple public health and disease-control measures at the village level. When implemented, the project - PUSH - served as the integration point of all health and related projects being implemented in the barangays.

The activities and accomplishments of PUSH were described recently by Iloilo Gov-ernor Conrado J. Norada, PUSH project director, in a paper presented to the Seventh National Population Welfare Congress in Metro Manila.

PUSH, Governor Norada said, uses a multidisciplinary health improvement approach which mobilizes existing community resources in providing development-oriented

It employs a barangay health services delivery model whose key figure is the barangay health worker (BHW). The BHW is a barangay resident who has been trained in environmental sanitation, family planning, nutrition, control of communicable diseases, cure of simple ailments, recording vital events such as births and deaths, and community organization.

The BHW's fulltime job is to provide integrated health, family planning and related ser-vices to his barangay. Among other tasks, he or she mobilizes the community res-

idents for the construction of sanitation facilities, motivates potential family planning acceptors and provides users with contraceptives, and promotes breastfeeding and other health practices. He administers treatment to simple allments and refers more complicated cases to medical facilities.

ments and refers more complicated cases to medical facilities. He also supports disease-control campaigns that may be conducted by the rural health unit in the municipality.

The barangay health delivery system is managed by the local government which, after the first three years of the project, assumed complete financial responsibility for all project responsibility for all project costs, including the salary of the

BHW.

Through 449 BHWs now being deployed throughout the island, PUSH has made available to the people of Panay a wide range of primary health, nutrition and family planning services.

It has provided immuniza-tion to a considerable number of children, and worked for the installation of sanitary tollet

PART 1. Within the first quarter of this year, the United States government updated its policy towards the Philippines. On the occasion of Fil-American Day, it might do well to revive that update,

Long standing political and economic problems came to a head following the Aquino assassination in August 1983, which destroyed most of the political credibility the 19-yearold Marcos Government enjoyed and exacerbated a shaky financial situation.

A positive political dynamic in the direction of greater openness has developed in the wake of the Aquino assassination, but many question whether President Marcos can or will allow sufficient revitalization of democratic institutions to prevent a full-scale polarization of Philippine

While President Marcos at this stage is part of the problem he is also necessarily part of the solution. We need to be able to work with him and to try to influence him through a wellorchestrated policy of incentives and disincentives to set the stage for peaceful and eventual transition to a successor government whenever that takes place.

Marcos, for his part, will try to use us to remain in power indefinitely.

The U.S. does not want to remove Marcos from power to destabilize the (Philippines).

Rather, we are urging revitalization of democratic institutions, dismantling "crony" monopoly capitalism and allow-"crony" ing the economy to respond to free market forces, and restoring professional, apolitical leadership to the Philippine military to deal with the growing communist insurgency.

NSSD: U.S. Policy Towards the Philippines, from the files so that we may see how the U.S., in its own words, views Ferdinand Mar-- and incidentally remind us how that "friend and ally" These efforts are meant to audiences and is an essential

stabilize while strengthening institutions which will eventually provide for a peaceful transition.

Our assets include not only the economic and military assistance that we are able to provide but also the respect and sympathy that we continue to enjoy with most segments of the Philippine population. Our support is one of Marcos' largest remaining strengths.

Our assets, particularly at the people-to-people level, could be lost if we come to be seen as favoring a continuation of the Marcos regime to the exclusion of other democratic alterna-

Public diplomacy involves Philippine and U.S. part of our policy.

As a first step, we would have to spell out our Philippine policy through a high-level (Reagan) Administration speech, followed by regular policy statements in Washington and Manila.

Since appearances and the perception of personal ties are the most important factor in the Philippine relationship, US offi-cials will have to take care not to appear too close to the Marcos regime.

At the same time, of course, officials will have maintain a relationship which is to continue to exercise influence the Marcos government) positively.

This is a thin line to walk but it can be done.

751 detainees still in AFP jails

Armed guards, barbed wire, steel bars. These are not unusual fixtures in Philippine military camps, and they tell only of one military stockades.

What makes these stockades quaint is that they house not only a few soldiers on AWOL (absence without leave) and common criminals, but also persons whom the Philippine government tags as "enemies of

While before the government treated these civilians as mere "detainees," it now calls them "national security offenders" or "public order violators."

President Marcos denies there are any "political prisoners" in this country of 54 million peo-

As political prisoners, as they are commonly known internationally, or as "prisoners of conscience," as some human rights groups classify them, around 70,000 Filipinos have been detained by the Marcos government since martial law was declared in 1972. Most of those detained, however, have been released after spending from several days to several

years, in a few instances even a decade, in detention.

In its latest report, the Task Force Detainees of the Philippines (TFDP), a human rights organization founded in 1974, revealed that there are at present 751 political detainees and prisoners still languishing in over 108 military camps, prisons and a military hospital all over the country

Of the total, 66 are being held in Metro Manila, 23 of whom have been "sentenced. ("Sentenced political pri

are those convicted of political offenses such as subversion or rebellion. "Unsentenced political detainees" are those not yet charged, those being tried in civil or military courts, or have been acquitted, or those whose cases have been dismissed but who are still in detention.)

The rest of the political detainees are distributed, thus: 146 in Luzon, outside of Metro Manila; 259 in the Visayas; 280 in the southern Philippine

Medicinal plants, acupressure and cupping or ventosa are considered most helpful. In terms of traditional beliefs, programs cite particular quali-ties such as the "wholistic" nature of traditional concepts of illness causation which consider man's natural and social

The last category refers to traditional medicine's disease-preventive component at little or no cost and ready availability. With traditional medicine, most non-governmental health programs hope that self-reliance in the field of health can be achieved in the near future.

US, Britain to press

BOYCOTT OF BEIRUT AIRPORT

LEBANON THREATENS TO SUE; WASHINGTON OFFERS REWARD

LONDON, July 3 (AFP) - The United States and Britain will push for an international agreement for a western boycott of Beirut international airport, Prime Minister Margaret Thatcher said today after talks with visiting US Vice-President George

She said London and Washington would as "a first immediate step" seek agreement at a Bonn meeting of top officials of 7 leading western democracies next week "to suspend all air services between their countries and Beirut international airport" following the latest hijack crisis there.

Britain and the United States "declare their determination to work together with all like-minded states in combatting this

evil," she said.
"In particular terrorism against international civil aviation and those millions of innocent passengers who today travel by air must be stopped," she added.

BEIRUT (AP) - Lebanon's Justice Minister Nabih Berri threatened on Wednesday to sue the United States before the International Court of Justice in the Hague if the US govern-

ment closes Beirut's airport to international travel.

His statement followed a warning issued by Islamic Jihad that the 7 American kidnap victims held by the shadowy Shiite Moslem extremist group "will face a black fate" if the United States attacks in Lebanon.

Berri, who played a key role in the release of the 39 American hijack hostages from Shiite captivity in Beirut three days ago, accused US President Ronald Reagan's administration of betraying its commitments."

"It's a betrayal that encourages violence against Lebanon and infringement on its security," said Berri, whose Shiite Amal militia held most of the TWA hostages during their 17day captivity.

Therefore I shall as justice minister make all the efforts needed to . . . sue the United States before the International Court of Justice in the Hague, demanding condemnation and cessation of the American retaliatory measures as well as compensation," he said.

Islamic Jihad, which claimed several suicide bombing operations against US targets in the Middle East in the past two

years, warned on Tuesday that its "lovers of mertyrdom" were ready to launch new strikes against the United States.

WASHINGTON (AP) - The administration of President Ronald Reagan is considering offering \$500,000 for the apprehen-sion of the Shiite militants who took over TWA flight 847 and killed a navy diver, White House spokesman Larry Speakes said

Wednesday.

Asked whether such a bounty offer was being made, Speakes said, "it's under consideration, yes."

Speakes said the offer is covered under an anti-terrorist law passed by Congress that authorizes the secretary of state to approve payments of individual rewards of up to \$500,000.

He said the law authorizes the secretary of state to give the rewards "to any individual who furnishes information leading to the arrest or conviction in any country of a person committing, or conspiring to commit, an act of international terrorism.

Asked whether the law meant the hijackers would have to brought to the United States in order to obtain the reward, Speakes said he did not know, but added: "I guess if somebody produced them, we could decide to give them the money.'

LOS ANGELES (AP) — The regime of the Ayatollah Ru-hollah Khomelni, which once held Americans hostage for more than a year in Iran, helped persuade Moslems in Lebanon to free the 39 TWA hijack victims, the Los Angeles Times reported

Wednesday.

Summit will take up arms

MOSCOW (AP) - Soviet leader Mikhail Gorbachev and US President Ronald Reagan hold a summit in Geneva on Nov. 19-20, a foreign ministry spokesman said Wednesday, adding that arms issues would be of paramount importance.

The meeting will be Reagan's first summit with a Soviet leader in the five years he has been president and Gorbachev's first meeting with a US president.

The brief announcement was made by the official Soviet news agency Tass. Soviet radio and television carried that report and foreign ministry spokesman Vladimir Lomeiko read it to reporters at a briefing.

Lomeiko also said Gorbachev would be going to France in October, which Tass had announced earlier Wednesday.

Lomeiko did not state what the summit agenda would be, but indicated disarmament issues would be a prime topic.

Asked what had changed to allow a summit now, in Reagan's second term, Lomeiko said, "The issue of a meeting of the two sides at the highest level is very important for the two countries. Both sides expressed on a number of occasions that such a meeting should take place when the necessary conditions had been created."

Indo-Pak exchange

NEW DELHI (AP) — India and Pakistan, subcontinent rivals for the past 38 years, agreed Wednesday to increase cultural exchanges in an attempt to improve their strained relations, an Indian government spokesman said.

The decision was reached at The decision was reached at the second-day meeting of the india-Pakistan Joint Commis-sion, which resumed talks in New Delin Tuesday after a two-year break due to frictions be-tween the two South Asian countries.

External affairs ministry spokesman Salman Haidar said the two sides agreed to increase exchanges of students, scholars, seminars, video and television programs and exhibitions as a step toward better cultural ties.

The delegates discussed the draft of a cultural agreement, which would be signed "in due course," Haldar told reporters.



Adaza filed resolution 559 calling for the immediate investigation into the "well-publicized" investments of Filipinos in America.

Mercury News, The reports detailing Filipino investments in America, named President Marcos, his wife, Imelda, Defense Minister Juan Ponce Enrile, Energy Minister Geronimo Velasco, Philsucom chairman Roberto Benedicto, Makati Mayor Nemesio Yabut, Antonio Cuenca, Floirendo, Rodolfo Ricardo Silverio, Eduardo Co-juangco, Jose Campos, Maurice Carpo, Herminio Desini, Edna Guiyab Camcam, Vilma Bautista, among others.

Adaza noted that the abovementioned persons are either top government officials or known cronies of the Marcos administration.

The Misamis Oriental lawmaker, citing published reports, said that the combined total investments of the persons named in the foreign news accounts, and the properties listed in their names with their corresponding values, is in the amount of \$347,006,646.00 or roughly P8,940,132,900.00, or one tenth of the national budget for 1985.

Adaza, on the other hand, said it is safe to assume that the properties which were not valued in the said news stories exceed by leaps and bounds the values of the properties which have their corresponding prices.

"It is the considered opinion of many knowledgable sources, said Adaza, "that the published investments abroad are but tips of the proverbial iceberg.'

In seeking a no-nonsense legislative probe on multi-million dollar Filipino foreign investments, the Misamis Oriental lawmaker stressed, "it is imperative that the Batasan as a lawmaking body should know how millions of dollars were siphoned to the US by those persons identified in the reports and determine whether it was done in violation of our laws that remedial legislation should be enacted."

island of Mindanao. Many of them claim to have been subjected to torture and sexual abuse by their military captors.

One hundred-six of the total are women, 31 of whom are mothers. According to TFDP, the average age of the political detainees is 30. The oldest, who is 66, is detained in Camp Bagong Buhay Rehabilitation Center in Cebu City, while the youngest – a boy of 10 – is held at the Inopacan Municipal Jail in Leyte island.

Farmers and workers, who bear the brunt of economic exploitation, comprise the majority of those still in detention. Four hundred-seven (or 72 per cent of the total) are farmers; 62 are workers. The third largest in number, according to TFDP's report, are professionals - 28 - with student detainees coming next - 21. This means, TFDP said, a 'growing awareness and involvement of the middle class in the pressing issues confronting the country today."

There are at least 171 longheld detainees, in jail for over a year now. The longest-held detainee, Renato Arao, has been in detention for nine years and 10 months. Arao, who was arrested by government soldiers in 1975, is currently held at the provincial jail in Pagadian City, Zamboanga del Sur, the province at the western flank of Mindanao island.

The TFDP also reported that the 23 long-held political pri-soners are serving their sen-

tences at the New Billbid Prisons and the Women's Cor-rectional. The longest-held poli-

rectional. The longest-held political prisoner is Gabriel Salonga, arrested on January 14, 1969 in Porac, Pampanga. A father of four, Salonga was convicted in October 1973 on criminal charges.

Still among the longest-held political detainees are Victor Corpus (9 years and 6 months) and Bernabe Buscayno (9 years). Corpus was a lieutenant in the Philippine Constabulary who reportedly defected to the Communist-led New People's Army in 1972 shortly after leading a raid on the armory of the Philippine Military Academy in Bagulo City. Buscaydemy in Bagulo City. Buscay-no is alleged to be the "Ku-mander Dante" whom the mili-tary says was the NPA head before his arrest in 1976.

tary says was the NPA head before his arrest in 1976.

University professor and poet Jose Ma. Sison, alleged first chairman of the Communist Party of the Philippines, was arrested in November 1977. Sison is presently detained at the Maximum Security Unit, Fort Bonifaclo, this city. He spent roughly half of his time in detention under solitary confinement.

According to the TFDP, in many cases political detainees cannot contest the arbitrariness of their arrest, a fact which makes their detention illegal. Most detainees report that they were arrested without proper warrants of arrest. Others have yet to see copies of the arrest orders issued against them by President Marcos.

"Already denied of their right against arbitrary arrest, some detainees have also been stripped of their right to due process," the TFDP also sald. At least 56 detainees are being detained without formal

At least 56 detainees are being

process," the TFDP also said. At least 56 detaineds are being detained without formal charges. On the other hand, some detainees have been slapped with criminal charges such as murder and illegal possession of firearms.

Others who have been charged in court are facing a kind of legal limbo. They include those already ordered released but who remain incarcerated and those who have been granted bail but cannot be set free because their military custodians refuse to release them.

In 1976, Defense Minister Juan Ponce Enrile issued a circular authorizing the release of nursing mothers and in the case of a detained couple, the release of one of the detained spouses. Despite the Enrile circular, however, military authorities still refuse to re-

spouses. Despite the Enrile circular, however, military authorities still refuse to release seven nursing mothers. Sixteen detained couples continue to languish in jail.

The TFDP report coincides with the current campaign for the release of all political detaines in the Philippines. Involved in the campaign are the TFDP itself, KAPATID (Kapisanan para sa Pagpapalaya at Amnestiya ng mga Detenido sa Pilipinas, an association of relatives and friends of political detaines), as well as other human rights and church-based organizations.

Sasakawa told a news conference that his organization had received a letter from IOC president Juan Antonio Samaranch dated June 6 announcing official IOC recognition of the

The union is working to have karate made an Olympic event by 1992, Sasakawa said.

He said the union is made up of 76 countries including Australia, Britain, Canada, The Philippines, Denmark, Norway, Switzerland, New Zealand, Thai-land, West Germany, the United States, India, Pakistan and Japan.

Union officials said karate is practiced by an estimated 20 million to 25 million people in more than 120 countires.

Zola Budd, who romped away with the world cross country championship in March, will face Olympic 3,000 meters champion Maricica Puica of Romania when she attempts to break the women's 5,000 meters world record at the world games athletics meeting here Thursday.

Kristiansen failed in her bid to break her own world record of 14 min. 58.89 sec. the Bislett games at Oslo. It will be the South Afri-

can-born Budd's first clash with Puica since the Los Angeles Olympic final in which she finished seventh after her dramatized collision with American favorite Mary Slaney (Decker).

Puica, who claims she would have won in Los Angeles anyway, has pleaded to be allowed to run in a scheduled showdown between Budd and Slaney in London on July 20.

The triple jump could devel-op into an exciting competition with Willie Banks of the United States, who last month set a world record of 17.97m, facing Zdzislav Hoffmann, the un-heralded Pole who beat him in the inaugural world championships here two years ago.

Curren ends Mc's dream

It came in 3 sets

WIMBLEDON, England (AP) Defending champion McEnroe crashed out of the Wimbledon tennis championship in straight sets Wednesday, beaten 6-2, 6-2, 6-4 in the quarterfinals by Kevin Curren, the No. 8 seed.

McEnroe's defeat. which followed Monday's elimination of Ivan Lendl, No. 3 seed Jimmy Connors emerged as the highest seed left in the semifinals after beating Chilean qualifier Ricardo Acuna 6-1, 7-6 (7-3), 6-2.

Connors and Curren will meet in one semifinal while Anders Jarryd of Sweden, the No. 5 seed, won through to face the 17-year-old unseeded West German Boris Becker in the

German Boris Becker in the other.

Jarryd beat Switzerland's Heinz Guenthardt 6-4, 6-3, 6-2 while Becker, the rising young star of European tennis, continued his relentiess charge through the championships, serving 12 aces on the way to a 7-6 (9-7), 3-6, 6-3, 6-4 victory over Henri Leconte of France.

He was believed to be the youngest player ever to reach the semifinals of the men's singles at Wimbledon.

Curren, whose power serving, sharp returns and lightning passing shots contrasted with a strangely listless McEnroe, won in one hour, 49 minutes to reach the semifinals for the second time in his career.

A fired-up Connors, who looked relaxed and confident, produced several spectacular winners to end the brave challenge of Acuna, ranked 133 in the world.

After being swept aside in the opening set which took just 19 minutes, the South American broke Connors' serve early in the second and held a 5-3 lead.

But while Acuna blew hot and cold, mixing up inspired shots with dreadful mistakes, Connors broke back with a

series of his notorious service returns.

Leading 6-5, the 32-year-old American, who last won the title in 1982, squandered three set points before Acuna pushed the set into a tiebreaker.

Connors again raised his game to race into a 4-1 points lead and eventually clinched the stanza on his fifth set point, when Acuna hit a weak forehand into the net.

in the final set, Connors broke in the first game, then again in the seventh and moved confidently into his ninth Wim-bledon semifinals.

McEnroe, who was aiming to become the first American to win the Wimbledon men's singles crown three straight times, never got to grips with the sheer pace of Curren's game and appeared both mentally and physically slow.

The 26-year-old New Yorker won the title in 1981, 1983, and 1984 and had not lost a singles match here since American Jimmy Connors beat him in a final three years ago.

Asked whether there was any time in the match where he thought he might still win, Mc-Enroe repiled jokingly: "Only if he broke an ankle or something, he completely outplayed me."

Defending champion Martina Navratilova came through her toughest set of the tournament to date before beating Pam Shriver 7-6 (7-5), 6-3 to reach the semifinals of the women's shortes.

Chris Evert Lloyd, joint top seed with Navratilova, conti-nued her quest for the grand slam by crushing Barbara Potter 6-2, 6-1.

Two other Americans, Zina Garrison and Kathy Rinaldi, also reached the last four. Garrison, the No. 8 seed, beat the last surviving qualifier in the women's event, Molly van Nostrand, 2-6, 6-3, 6-0 while Rinaldi scored a bizarre 6-1, 1-6, 6-1 victory over Helena Sukova of Czechoslovakia.
