JOSE S. ARCILLA, S.J. is the archivist of the Philippine Jesuit Province and professor of history at the Ateneo de Manila University. He holds a doctorate from the Universidad Complutense de Madrid. Among his published works is *An Introduction to Philippine History*.

MA. LOURDES S. BAUTISTA is a Ph. D. in Linguistics from the Ateneo PNC (Philippine Normal College) consortium.
